A. Recommendations

THAT Council receive Staff Report CSOPS.22.038, entitled "Bridges 2 and 3 PIC Follow-up" for information purposes.

B. Overview

This report outlines the comments received from the Public Information Centre (PIC) held virtually on February 28, 2022, for the replacement of Bridges 2 and 3 also known as Mitchell's Creek Bridges.

Furthermore, this report is provided to Council to update the status of tendering for the replacement of Bridges 2 and 3.

C. Background

The Town issued the Notice of Commencement on April 11, 2019, for a Class EA (EA) under the Environmental Assessment Act to determine the preferred methods of improvement to address structural conditions and roadway safety at Bridges 2 and 3.

Bridges 2 and 3 span Mill Creek on 6th Sideroad, 375 m west of 10th Line. Bridges 2 and 3 are monolithic T-beam bridges that were constructed in the 1930s. An overview map of the location of Bridges 2 and 3 can be seen in Attachment #1.

The bridges have severe deterioration, do not meet current standards and have been posted with reduced load ratings. Bridges 2 and 3 are posted at 10 Tonne. The 2017, 2019 and 2021 Town-wide bridge inspection program (conducted every other year) has identified that replacement of Bridges 2 and 3 will be needed within the next 1 to 5 years and the condition index is described as poor.

The EA completed the phases associated with a Schedule 'B' project and identified a preferred solution and after further consideration and feed-back from Council during the presentation of

initial study conclusions (Staff Report CSOPS.19.078), the preferred option was to replace Bridges 2 and 3 with single lane bridges or structures (see Attachment #2).

In late April 2021, the Town awarded the contract for the completion of the detailed engineering design and contract administration to Tatham Engineering Limited (Tatham). It is anticipated that the detailed design will be completed in the first quarter of 2022 with construction beginning in the second quarter of 2022.

As part of the project scope, Town staff identified the need for a public consultation session. Ordinarily this would include a PIC where the public can review the information and ask questions in-person. In lieu of a traditional PIC, Town staff hosted a "Virtual PIC" event where the project was presented to the public via online streaming (similar to Council Meetings). The public will also be able to write-in comments which can be responded to live or following the meeting.

Further, staff proceeded with a Request for Tender (RFT) for construction of the replacement of Bridges 2 and 3.

D. Analysis

The PIC was held on March 3, 2022. The PIC was held virtually on Microsoft Teams from 5:00 p.m. to 7:00 p.m. A total of 14 individuals attended the meeting.

Included below is a summary of the primary concerns heard in the lead up to and throughout the PIC. A detailed breakdown of the specific questions and comments that were received can be found in Attachment #3.

Project Timing and Detour Route

A concern was voiced regarding the project being completed prior to 9th Sideroad becoming unnavigable by snow, and also about increased traffic on 9th Sideroad. Town Response – The primary detour for this project has been identified as Grey Road 119 which does receive winter maintenance.

Emergency Services Awareness

A comment was received regarding Emergency Services being made aware of the road closure. Town Response – EMS will be notified of the planned closure dates in advance of construction.

Pedestrian and Cyclist Access

A comment was received regarding the possibility of a pedestrian and cyclist crossing being maintained during construction.

Town Response – The project site is not capable of accommodating a pedestrian or cyclist crossing route during construction.

The replacement of Bridges 2 and 3 project was approved in the <u>2021 Budget</u> at a total of \$2,210,000. This is further broken down by the following:

\$ 270,000 Engineering\$1,740,000 Construction\$ 200,000 Contingency.

The Town's consultant Tatham provided a 95% Engineer's estimate of projected construction costs of \$2,043,335.00 including a \$200,000 contingency.

RFT 2022-33-T-OPS, Replacement of Bridges 2 and 3 was advertised and tendered in accordance with the Town of The Blue Mountain's Purchasing Policy and Procedures. The bidding opportunity was issued on Wednesday March 30, 2022 with a closing date of Thursday April 21, 2022.

Forty-six (46) companies, suppliers and associations requested copies of the bid document and Five (5) bid submissions was received and one (1) bid submission was disqualified due to non-submission of mandatory submission requirements. The official bid results are as follows:

Operations staff as well as Tatham have reviewed the tender for completeness and mathematical correctness.

The lowest compliant bid in the amount of \$1,766,269.50 (includes \$200,000 contingency) was submitted by HugoMB Contracting Inc. The lowest compliant bid was \$277,065.50 lower than Tatham's estimate and staff do not anticipate a budget shortfall; therefore, will proceed directly to award.

Next Steps

Staff will award the construction contract to the lowest complaint bid, HugoMB Contracting Inc. and will proceed to the removal and the replacement of Bridges 2 and 3 with a proposed construction start date of June 2022.

E. Strategic Priorities

1. Communication and Engagement

We will enhance communications and engagement between Town Staff, Town residents and stakeholders

2. Organizational Excellence

We will continually seek out ways to improve the internal organization of Town Staff and the management of Town assets.

3. Community

We will protect and enhance the community feel and the character of the Town, while ensuring the responsible use of resources and restoration of nature.

4. Quality of Life

We will foster a high quality of life for full-time and part-time residents of all ages and stages, while welcoming visitors.

F. Environmental Impacts

Significant alterations to municipal infrastructure require prescribed environmental study, which take into consideration the impacts the solutions could have on the natural and cultural environment. The level of impacts in each option are weighed against other impacts such as cost. Options for mitigating natural and cultural impacts (such as historic significance) are also put forth.

G. Financial Impacts

This capital project was approved in 2021 with a total budget of \$2,210,000, this project is trending under-budget as both the engineering and construction costs have come in under-budget. This project has some Federal Gas Tax funding however the majority of the funding will be long-term debt. Before taking out any long-term debt staff will review all available funding sources to see if long-term debt can be avoided.





Re: Bridge 2 and 3 Replacement – Public Information Centre (PIC) #1

This memo is intended to provide a summary of the questions, comments and answers that were received prior to, or asked during, the PIC held on March 3, 2022. The PIC was held virtually on Microsoft Teams from 5:00 p.m. to 7:00 p.m. A total of 14 individuals attended the meeting.

Included below is a summary of the primary concerns heard in the lead up to and throughout the PIC, as well as a detailed breakdown of the specific questions and comments.

1. Project Timing and Detour Route

A concern was voiced regarding the project being completed prior to 9th Sideroad becoming unnavigable by snow, and also about increased traffic on 9th Sideroad. Town Response – The primary detour for this project has been identified as Grey Road 119 which

3. Pedestrian and Cyclist Access

A comment was received regarding the possibility of a pedestrian and cyclist crossing being maintained during construction

Town Response – The project site is not capable of accommodating a pedestrian or cyclist crossing route during construction

The following questions were received prior to the PIC, and addressed again during the PIC

Can residents be assured that this project will be completed by the time 9th Sideroad becomes unnavigable by snow? – Kevin Walsh, via email

The primary detour for this project has been identified as Grey Road 119 which is maintained during the winter. There will be a stipulated completion date in the construction contract of either mid to late November or early December, but weather conditions may leave the alternate detour routes of 12th Sideroad and 9th Sideroad unnavigable by the time construction is completed.

Given the increased traffic expected on the 9th Sideroad, are any mitigation measures planned for that road? It is narrow and has some blind corners. – Kevin Walsh, via email

The primary detour route will be Grey Road 119, and therefore there are no improvements planned for 9th Sideroad through this project.

How are local fire and ambulance services being updated about these closures? - Kevin Walsh, via email

EMS are being notified of the planned closure dates. Once those dates are confirmed they will be able to plan accordingly to make use of the alternate routes.

During the bridge replacement, while the bridge is closed to motor vehicles, will it be possible for pedestrians and cyclists to still cross? – Kevin Walsh, via email

No, the structures being replaced are only a single lane wide and there is not enough room to stage the construction area to accommodate a pedestrian or cyclist crossing route.

The following question was received following the PIC

What is the construction timeline, and are both bridges being replaced? - Al Stuart

Construction is planned to occur May to November. Both bridges are being replaced with new single-lane bridges with a clear width of 4.9 m. The new bridges will not have a load posting.

Follow-up comment: Al and his brother own the farmland around the bridge sites, and noted that access to their farmland would be a challenge.

It was explained that the geometry of the bridges makes it not possible to maintain a lane of traffic during construction.
