# C. Matters for Discussion

#### C.1 Grey County and The Blue Mountains Recreational Spaces Update – Director of Community Services Ryan Gibbons

- Facilities remain open, as identified and approved by Council, but are not proceeding with further re-opening at this time due to the region being moved to Yellow Zone with respect to COVID-19
  - Staff is reaching out to Public Health to clarify programming at the Community Centre
  - It was noted there is some confusion with respect to programming in community centre/hall versus the arena:
    - Pickleball proceeding per the Public Health reviewed operating parameters
    - Phase 2 programming at the arena (game time, adult hockey, curling) not proceeding at this time
- Tomahawk and Georgian Trail will have recreational opportunities for winter 2021

# C.2 Holiday "Shop Local" Campaign Update – Give the Gift of Blue – Manager of Communications and Economic Development Tim Hendry

- Special Committee of the Whole meeting November 12, 2020 staff gained support to proceed with the "Give the Gift of Blue" shop local initiative
- Campaign November 30, 2020 to January 3, 2021

# Derek Hammond

- Requested clarity regarding whether the Provincial extension of patios to end of December 2020 are also being permitted in The Blue Mountains – Mayor Soever advised he will follow-up
- Noted there is fatigue by visitors who are expressing frustration at the continued safety protocols (maximum number of guests/table, masks, etc.)

# **Rob Cederberg**

- Currently requiring reservations by a maximum number of 2 guests per booking
- Staff recommending to those purchasing services to adhere to public health recommendations to not travel out of their area at this time

# Sarah Filion

- Visitors in Clarksburg are courteous and following health and safety protocols
- Noted recently there have been a number of day-trippers
- Clarksburg Tour of Lights (self-guided, walking or driving) beginning December 12, 2020

# Peter Bordignon

- Noted there has been an increased tension between full-time residents, parttime/seasonal residents, and visitors to The Blue Mountains, and cautioned that the Town and its stakeholders must ensure messaging does not further the divide
- Advisory participants noted there is divisive language used on social media by various private individuals towards seasonal residents which makes the divide greater
- Mayor Soever noted unnecessary travel is not recommended at this time and a
  person's behaviour in the community is far more important than where he or
  she is from Mayor Soever noted Public Health has confirmed transmission is
  happening in people's homes, not at restaurants and businesses, and pointed to
  information provided on the Health Unit website (with respect to the recent
  cases in Kincardine) and noted Dr. Ian Arra joined the Mayor's Weekly Message,
  November 20, 2020 to discuss the recent case increase
