### *RE: Invitation to Pre-Qualification and Public Information Session Tuesday, February 16, 2021 at 3:30 p.m.*

The Town of The Blue Mountains is looking to assist competent and qualified internet service providers (CQISPs) who will provide broadband internet services to one or more underserved areas within the Town. To this end the Town has established the Rural Access to Broadband Internet Technology (RABIT) Task Force.

The Task Force's mandate is to identify ways in which the Town can assist in bringing Broadband technology to <u>all</u> parts of the Town. To this end it is inviting all CQISPs to the public information centre (PIC) on February 16, 2021, where they can introduce their capabilities to Council and the public.

This would be a virtual meeting. Format would be an introduction by the Town outlining the goals of the RABIT task force, the current situation, followed by a five minute presentation by each of the CQISP's on their capabilities and services, followed by questions from Council.

Attendance at this meeting is requested as the Town wishes to be introduced to suppliers and understand the opportunities that currently exist, opportunities that may be available in the future and to help inform the members of the task force, Council, staff, and members of the public. Proponents will be asked to provide suggestions to the RABIT task force on how the task force can promote the provision of broadband internet services to all the underserved areas within the Town. Ideally, this introductory session initiates a process that results in our rural areas being provided with internet in the near future.

Suggestions received will be used to formulate Requests for Proposals, which will be circulated to all pre-qualified CQISPs. (ie. those that have participated in the PIC and RFI process).

The Town of The Blue Mountains is a community located just west of Collingwood within the rolling landscape of the Niagara Escarpment on the sparking shores of Georgian Bay. Our community is home to many unique towns, hamlets and villages along with over 11,000 hectares of productive agricultural land. The Blue Mountains is known for its world-class ski resorts, hiking and cycling trails, boating, fishing and paddling experiences, golf courses, rock climbing and of course, kilometers of pristine waterfront.

It is these features that make the Town of the Blue Mountains, a very popular place destination to visit and to live, work and play, and that have made us one of the fastest growing communities in Ontario.
