

What is being proposed?

The purpose of this application is to consider a request for minor variance to Section 6.2 *Residential Zone Standards* of Zoning By-law 2018-65. The Owner is seeking a minor variance to the permitted minimum interior side yard setback to permit the construction of a three-season room attached to the existing single detached dwelling.

The effect of the application is to permit the construction of a three-season room attached to the existing single detached dwelling with a minimum Northern interior side yard setback of 1.0m; whereas 5.0m is permitted.


