C.1 COVID-19 Update – Mayor Soever

- Reviewed data and trending for COVID-19 in Ontario and Grey/Bruce Counties, and noted the increase in cases and hospitalizations
- Council heard from Business stakeholders, tourism operators, and business association representatives during the January 4, 2021 Special Meeting of Council

C.2 Overview of Holiday Operations in The Blue Mountains – All Attendees

- Noted an outbreak had occurred in a Town Department that does not regularly interact with members of the public
 - Notification was provided by the Town to members of the public
- Expressed thanks to Public Health representatives for diligent contact tracing and assistance

C.3 "Give the Gift of Blue" Update – Manager of Communications and Economic Development Tim Hendry

- Campaign ended January 3, 2021 with more than 1,000 entries
- Economic impact of the campaign ranged between \$49,000 to \$117,000
- Campaign well-received by business community and members of the public
- Expressed thanks to business stakeholders for assisting with marketing and promotion of the event

C.4 Christmas Dinner and Video Event Recap – Councillor Bordignon and Councillor Sampson

- Video was very professionally done and included elements of faith, the natural environment, and the community
- 250 meals distributed through the Community Cares program, and 250 meals were distributed at Beaver Valley Community Centre on December 19, 2020
- Any surplus revenue will go towards the Community Cares initiative
