B.1 Matters arising from January 6, 2021 Large Task Force (if needed)

Requested Property Tax Deferral

- Director of Finance and IT Services Ruth Prince is bringing an Interim Tax staff report to Council on January 12, 2021
 - If Council wishes to, they can consider waiving penalty and interest at that time
 - Mayor Soever noted Council could consider requesting the Province to defer schoolboard tax
 - Noted that any waiving of property tax will impact the proposed 2021 budget

Educational Campaign for Businesses

- Communications and Economic Development Coordinator Carling Fee noted there is an opportunity to provide explainer videos, or similar, to enhance customers' ability to locate businesses online
- It was noted a priority for 2021 is the development of a Social Media Strategy
- Noted the request for extension or renewal of the Shop Local campaign could include a regional focus

Winter Recreation in The Blue Mountains

- Georgian Trail and Tomahawk recreational opportunities have been received positively by the community, with significant use
- Town of Collingwood is now maintaining the Georgian Trail through its jurisdiction, which means the trail is groomed from Christie Beach to east of Collingwood
- Noted there has been no follow-up from the Province regarding the request to use the Provincial Park in Craigleith for recreational opportunities
