Acting Director of Finance, Sam Dinsmore introduced himself to the Committee and provided a brief overview of Staff Report FAF.23.153, entitled 2023 Grants and Donations Applications and provided information to the Committee on the amount of money that was available for donations.

Deputy Mayor Bordignon noted that the Clarksburg Village Association will be removing the ask for \$8,000 through this committee as it is being requested through another committee, the Economic Development Advisory Committee, or the Economic Development Department.

Director Gibbons provided information to the Committee on how the subsidy requests work through the Community Services Department noting the groups will come forward to off set the costs of a rental fee at a Town facility, being a park, pavilion, or hall, generally for an event.

The Committee discussed the request from the Lion's Club, which was noted in the application as funding needed for a new trailer. The Committee discussed and agreed that capital spending was not in the purview of this Committee.

The Committee discussed each application and the cash and subsidy requests contained in the applications noting that the "asks" total \$88,000 and there is \$48,000 in funds available.

The Committee discussed hosting Lobsterfest, potentially a gala and a lottery.

Member Lapstra noted that the lottery may be the best route to not step on toes of other fundraising efforts in the Town. The Deputy Mayor Bordignon noted that galas are a good way to raise funds and noted that the Town is not able to host a lottery, so we would have to utilize the not-for-profit organization that Member Stewart is a part of, for the endowment fund. Deputy Mayor Bordignon noted that he will speak to Town staff and will work with Member Stewart's foundation to see what we can do. Member Stewart noted that lotteries are tough to organize, and you require a lot of people to raise enough money and she further noted that Owen Sound stopped holding lotteries as they were losing money.

The Committee discussed hosting Lobsterfest and briefly discussed the options of having it at Bayview Park, where there can be a lot of people accommodated outside or would it be better to only offer take-out, or a hybrid of both. Deputy Mayor noted that this event would have to be at the end of May or beginning of June, before the Fish Fry at St. George's Church and in order to have fresh lobster at a reasonable price. Member Stewart noted her support for Lobsterfest and further noted that it is ran by volunteers, costs were low and is a popular event with residents of the Town.

Member Stewart spoke regarding the gala noting that her idea is to host it at Town Hall and call it "Dinner on the Town", with a long table set up. Member Stewart further noted that it does not have to be a black-tie event, it can be casual dress as well. Member Stewart further suggested using local chefs and restaurants which would allow the local restaurants to show their culinary skills. The Deputy Mayor suggested creating a sub-committee for this specific event and can discuss ideas, what we can do and where we can do it.

The Committee discussed penciling in the date of June 1, 2024, for Lobsterfest.

Madam Mayor noted that there are more meetings than there have been in the past and there are hard decisions to make.

Mayor Matrosovs noted that the Deputy CAO provided a report on Bill 134, the Affordable Homes, and Good Jobs Act, 2023. Mayor Matrosovs encouraged the report be read noting it was well laid out with perspective and implications on a multi tier

government, trying to provide the homes we need, while ensuring they are the ones that are needed.

Mayor Matrosovs noted that on-farm diversification was discussed, and how it relates to Grey County Official Plan. Noting that diversified use needs to be agricultural related, supporting the agricultural community as well as those farmers who needs an extra income given the challenges farming can pose when supporting a family.

Mayor Matrosovs further noted that Grey County will also be putting together a list of submissions for the ROMA Conference.

Deputy Mayor Bordignon noted that the region discussed economic development and transit, noting that this is a topic that needs to be viewed regionally including cost, what is being spent now and opportunities to save money while continuing the service as it does affect our residents.

WHEREAS the Town of The Blue Mountains recognizes that its trees are vitally important to the social and economic wellbeing of the community and its people. Trees create an aesthetically pleasing environment, while instilling a sense of community stability and history;

WHEREAS provincial direction to increase density in existing neighbourhoods and create more affordable housing, such as second suites, within existing properties has raised the question of protection of individual trees on residential lots;

BE IT RESOLVED THAT The Town of The Blue Mountains develop a Tree Program – A program designed to enhance the appearance of the municipality and further the welfare of the residents by the planting, maintenance, protection and preservation of public trees, including the establishment and implementation of the master tree plan and the specifications;

BE IT RESOLVED THAT Council of The Town of The Blue Mountains through its direction that Town employees continue to be responsible for the planting, maintenance and removal of trees located on Town streets and other municipally owned lands. The Council will preserve existing and established new trees on all suitable Town property and encourage the same type of management on privately and institutionally owned lands. These activities will be directed towards a goal of providing a permanent canopy of healthy trees throughout the Municipality;

BE IT RESOLVED THAT Council of The Town of The Blue Mountains direct staff to develop a report in regards to tree standards committee or task force that includes representatives from Town Staff and Council, the Land Development community, the Agricultural community, the Professional consulting community and the TBM Tree Trust to review and update tree protection standards, explore additional community partnerships and incentive programs, such as grants, and educational programs to plant more trees on private and public land

Tree Compensation /Replacement Plans will be required in the planning application process until an Ecological Offset Policy is developed and implemented by means of a bylaw as stated above.

AND THAT it is also suggested that, if appropriate and feasible, representation of the provincial government, upper-tier municipalities and conservation authorities also be invited to attend;

AND THAT staff are urged to seek collaborations with service clubs, not-for-profits organizations, individuals, and private enterprise to act as hosts and sponsors for these engagements, thereby fostering a regular and respectful dialogue throughout the year without undue financial burden on our constituents;

AND THAT such measures aim to ensure that all citizens are provided with equitable opportunities to engage with their municipal government, thereby enhancing the democratic process and nurturing a more inclusive community within the Town of The Blue Mountains

AND THEREFORE Council is encouraged to:

- 1. Direct pertinent municipal staff to conduct a comprehensive investigation into and subsequently develop strategies to promote informal settings for interaction between elected officials of the Town of The Blue Mountains, and where feasible, representatives of upper-tier municipalities and conservation authorities, with the citizens they serve.
