## C.1 Town of The Blue Mountains Mapping – Manager of IT Cathy Bailey and GIS Specialist Steve Aldred

- Reviewed mapping for The Blue Mountains (current as of approximately 1 year ago based on SWIFT and Federal mapping) that detailed Broadband Internet Data Service Speed, Service Type, Satellite Technology, Mobile Wireless Technology, DSL Technology, Coaxial Cable Technology, Fibre Optic Technology
- It was requested that staff pull additional information into the mapping to include information on internet services available for Municipality of Meaford and Grey Highlands
- Canadian Internet Registration Authority ("CIRA") is a helpful tool
- IT staff cautioned about judiciously posting information being collected that is not otherwise provided through SWIFT or the Federal Government
- Updated maps could be framed as "Public Access to Fibre Technology" and mapping should be available at the February 16, 2021 meeting
  - Should include analysis of number of potential customers currently outside of 50/10 coverage (potentially use a density map)

## C.2 Internet Service Provider Public Information Centre – Finalize Notice, Letter, and develop Presentation
