A. Recommendations

THAT Council receive Staff Report FAF.24.093, entitled "Rural Economic Development Program Agreement – Open Fields Grant";

AND THAT Council approve the authorization for the Mayor and Clerk to execute the contribution agreement.

B. Overview

In early 2024, the Town was successful in an application for the Rural Economic Development Program (RED) to support funding to host a community farm/agriculture familiarization tour. The "Open Fields" project, which held its first successful event in 2023 and drew over 2,000 visitors to five local farms, will provide the public with a behind the scenes look into agriculture practices in the region. This report seeks authorization to execute the contributing agreement.

C. Background

The Town submitted the RED Grant application in 2024 to fund the "Open Fields" project. This project will once again host a community farm/agriculture familiarization tour to the public. Working with the Agricultural Advisory Committee, the Town has taken various actions to increase public awareness of common agricultural practices and the importance to support the Agri food value chain in the region. Through the first "Open Fields" event, newsletters and business spotlights, the Town has provided helpful information to the public. Continuing "Open Fields" is a great opportunity to expand this initiative and to invite the public onto local farms to learn about their operations, to experience their products and to ask questions.

D. Analysis

Authorization to execute the contributing agreement will secure grant funding to support the "Open Fields" project.
