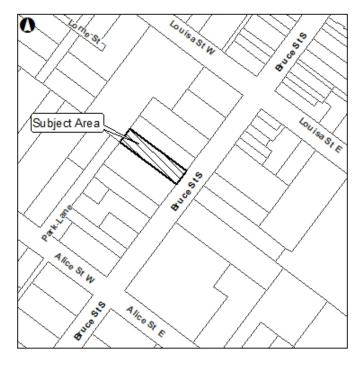

### What is being proposed?

The purpose of this application is to convert an existing 139.97 m<sup>2</sup> two (2) storey detached garage into an accessory residential unit. Internal renovations are proposed. No changes to the exterior. Variances are required as the existing structure is larger, taller and located closer to an interior side yard setback.

The effect of this application is to request a minor variance from Sections 4.1.2 (a), 4.1.3 (b) and Table 6.2.1 of the Zoning Bylaw to permit:

- 1. An increase to the maximum gross floor area from 100 m² to 140 m²;
- 2. An increase to the maximum building height from 5m to 7.16m; and
- 3. A reduction to the interior side yard setback from 2m to 1.56m

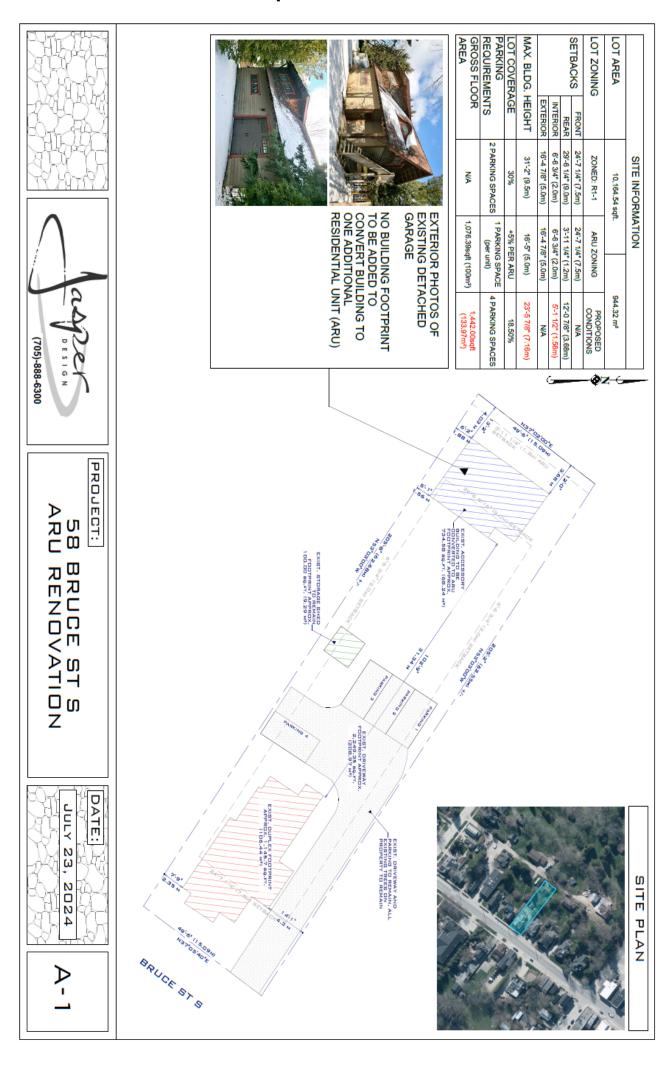
