Two full-time Municipal Law Enforcement Officer (MLEO) positions were posted in August 2024; one to fill a recent vacancy due to promotion, and one to fill an upcoming vacancy due to retirement. These positions were filled externally and employment of the successful candidates, Jeremy Dufour and Kylie Quesnelle, commences on September 9, 2024 and October 15, 2024, respectively.

## The Corporation of the Town of The Blue Mountains

### By-Law Number 2024 –

#### Being a By-law to appoint a Municipal Law Enforcement Officer

Whereas Section 11 of the Municipal Act, 2001, authorizes the council of a local municipality to enact by-laws respecting matters within its sphere of jurisdiction and refers to municipal law enforcement officers;

And Whereas Council of The Corporation of the Town of The Blue Mountains deems it expedient to enact a By-law to appoint a person as a Municipal Law Enforcement Officer to enforce the by-laws of the municipality;

And Whereas Council has received Staff Report CSOPS.24.072 “Appointment of Municipal Law Enforcement Officers”;

Now Therefore Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

1. Jeremy Dufour is hereby appointed as a Municipal Law Enforcement Officer to enforce the by-laws of the municipality effective September 9, 2024; and
2. Kylie Quesnelle is hereby appointed as a Municipal Law Enforcement Officer to enforce the by-laws of the municipality effective September 9, 2024

And Further that this By-law shall come into force and take effect upon the enactment thereof.
