Licensing and Administrative Monetary Penalties Revisions

- Administrative Monetary Penalty (AMP): Is a fine set and issued by the Town as identified in the Town's Administrative Monetary Penalties By-law 2021-71 (AMPs cannot be punitive)
- **Demerit Points:** Points applied to a Short Term Accommodation (STA) license, to a maximum of 15 points, based on an offence committed as identified in the Town's Licensing By-law 2021-70
- **Provincial Offences Act (POA):** Fines that are approved by the Province of Ontario for specified offences outlined in Municipal bylaws (save and except the Licensing and AMPs by-laws) or Provincial Acts (ex. Building Code Act, Fire Protection and Prevention Act)
