A. Recommendations

THAT Council receive Staff Report CSOPS.24.064, entitled "Response to deputation of Ms. Crosskill regarding Bayview Park Playground Project";

AND THAT Council direct staff to include this project in the 2025 budget with funding recommendations to include rubberized play surfacing.

B. Overview

The playground equipment located at Bayview Park is scheduled to be replaced in 2024, \$200,000 has been budgeted for the project with the intent of using engineered wood fiber chips for the protective surfacing. Our panel of residents has indicated that a poured rubber play surface is a much more accessible surface and would like to see it installed over the wood fiber chips.

C. Background

The playground equipment located at Bayview Park is scheduled to be replaced in 2024, \$200,000 has been budgeted for the project with the intent of using engineered wood fiber chips for the protective surfacing. Our panel of residents has indicated that a poured rubber play surface is a much more accessible surface and would like to see it installed over the wood fiber chips.

Working with the playground contractor, they provided 2 original designs to bring forward to a working group of 4 individuals for some public feedback on accessibility. Our first meeting took place May 27th. This is when the group first initiated the conversation about moving to the rubberized surface which was not budgeted for. The playground contractor provided a preliminary estimate of \$140,000 to install the rubberized surface. Quotes from the rubber companies are coming in at a similar price ranging from \$130,000 to \$180,000.

The working group took the initial designs to the Kids Day at Lions Park on June 22nd for more public input into the preferred design and play elements for the playground attachment #1 (see attached original playground design). With the input from the fair as well as ongoing correspondence with the working group we were able to sit down on August 7th and come up with a final list of equipment that takes accessibility of all levels into account and accommodates all users.

D. Analysis

Engineered wood fiber is considered an accessible and protective surface but in practical applications wheelchair users struggle to travel over the surface as well as have issues with small scrapes and rashes from pulling themselves over the surface. The rubberized surface makes for a smooth, long lasting, low maintenance solution for all concerns.

E. Strategic Priorities

1. Communication and Engagement

We will enhance communications and engagement between Town Staff, Town residents and stakeholders

2. Organizational Excellence

We will continually seek out ways to improve the internal organization of Town Staff and the management of Town assets.

3. Community

We will protect and enhance the community feel and the character of the Town, while ensuring the responsible use of resources and restoration of nature.

4. Quality of Life

We will foster a high quality of life for full-time and part-time residents of all ages and stages, while welcoming visitors.

F. Environmental Impacts

To be considered through final design and construction.

G. Financial Impacts

The final design of the playground (Attachment #2) equipment cost is \$180,266.79 + HST leaving \$19,733.21 in the approved budget for the project.

The additional cost to change the surface from engineered wood fiber to the preferred rubberized play surface is approximately \$140,000.

The additional funding required to complete the project is approximately \$120,000.

















Deck Edge Buttons allows increased visibility for users and parents with special needs.


