#### A. Recommendations

THAT Council receive Staff Report FAF.24.127, entitled "Community Sport and Recreation Infrastructure Fund Stream 1";

AND THAT Council endorse the Town of The Blue Mountains in its effort to capture available funding through this grant opportunity.

#### B. Overview

The Province of Ontario has created the Community Sport and Recreation Infrastructure Fund (CSRIF) to extend the lifespan, maximize the use and improve the health and safety and accessibility of existing recreational facilities. The Town would like to apply for the grant to correct deficiencies at the Beaver Valley Community Centre. This would include new HVAC systems, repair critical structural defects and create more accessible programming space at the arena.

#### C. Background

The CSRIF was established by the provincial government to support the development and improvement of community sports and recreational facilities. The funding structure is between \$150,000 to \$1 million. All projects must be completed within 24 months of entering a Transfer Payment Agreement with the province.

### D. Analysis

The Town has historically budgeted \$500,000 for annual facilities improvements. This grant would allow the Town to complete additional higher value projects.

## E. Strategic Priorities

#### 3. Community

We will protect and enhance the community feel and the character of the Town, while ensuring the responsible use of resources and restoration of nature.

#### 4. Quality of Life

We will foster a high quality of life for full-time and part-time residents of all ages and stages, while welcoming visitors.

#### F. Environmental Impacts

If these projects are implemented the facilities will reduce energy and fossil fuel consumption, and ozone depleting refrigerants.

#### **G.** Financial Impacts

The grants would allow the Town to leverage already allocated facility improvement money to complete additional higher value projects.
