C.1 ICON Application Update, Blair Almond – Bruce Street Technologies

- Blair Almond, Bruce Street Technologies attended the meeting for Item C.1 to provide an ICON Application Update
- Blair has not received confirmation that the most recent ICON application was successful yet
- Noted the recent increase in government funding for broadband has increased lead time and competition for resources/fibre supply/equipment/staff
- 50/10 service mapping available is not current
- Confirmed that Internet Service Providers are aware of the location of dark fibre

C.2 Town of The Blue Mountains Mapping Update – Manager of IT Cathy Bailey and GIS Specialist Steve Aldred

- Reviewed updated mapping that includes a broader reach (Meaford and Grey Highlands) and density mapping
 - All mapping provided to date is public information and can be shared
 - Mayor Soever will present the mapping during the Internet Service Provider Information Centre with GIS staff on hand in case questions arise that require additional clarification
- Discussed amendment to the RABIT Task Force webpage that includes a link to the CIRA Internet Speed test
- Manager of Information Technology Cathy Bailey noted some dark fiber is not available for internet connection
