A.8 Chair's Remarks

Chair Oliver noted he was happy to have their first meeting in 2025 and that the Board had supported his position as Chair for another year, and thanked OPP staff for their support in attending the meetings. Chair Oliver noted this is the first full year of the Board under the new legislation and looks forward to this transition.

Chair Oliver noted that Council will be dealing with the OPP Detachment Board's first estimates as submitted and this will also be true of the new OPP Contracts for 2025 and for the next several years. Chair Oliver noted that when Council has their discussion about the OPP Contract budget itself, he would appreciate being informed of that and observe. Deputy Clerk Dunlop confirmed that members of the public and Board are welcomed to provide their comments on the Council Budget relating any item part of the Council Budget, including with regard to the OPP Board Estimates and OPP Contract.

Chair Oliver noted he received a copy of the correspondence regarding the special funding from the province that the Town is receiving regarding the OPP Contract.

Member Matrosovs noted that across the province this funding is welcome relief and will help us adapt to the new configuration moving forward. Member Ardiel noted that the funding is for 2025 only, and we will not know what will happen going forward. Member Ardiel noted ongoing discussions are happening through AMO and the province to try and secure funding for following years, and they hope this funding will continue otherwise every municipality in this province will see huge increases in taxation to cover these expenses.

Chair Oliver noted as a Board they had a responsibility to seek community input and be more proactive in seeking out participation and engagement.

C. Staff Reports

C.1 Detachment Commander Report, Quarter 4 2024

Detachment Commander Licharson provided an overview of the Detachment Commander's Report and introduced Acting Staff Sergeant Mark Stadig.

Chair Oliver asked about the questionnaire regarding local information or news, and asked if there was a differentiation for the particular question around how Town residents get the information versus Collingwood residents. Chair Oliver noted that for example, the Blue Mountain Review is a primary source for the Town versus the Collingwood Today news source. Detachment Commander Licharson noted he does not believe there is a statistical difference in this regard, and he would look into this further to report back. Detachment Commander Licharson noted there is still a strong need for local outreach. Chair Oliver asked if OPP staff can share the results of the specific survey with Board Members, which Detachment Commander Licharson confirmed they could share.

Chair Oliver noted he has had residents reach out to him about RIDE programs taking place throughout the Town and asked how strategic OPP Staff were in terms of where and when the programs would be implemented. Detachment Commander Licharson noted that officers work together to ensure good traffic flow and use data analysis to see where previous arrests for impaired have taken place, as well as rely on local officers for their discretion as they know the areas of concern to target.

Member Ardiel noted that some incidences had jumped by 50 percent and asked if these incidences were from residents or visitors. Detachment Commander Licharson

noted that the holiday season is a factor for all the offence categories because the Town is a tourist destination and sees an increase in the number of people in the area. Detachment Commander Licharson noted that the numbers from 2022 to to 2024 saw a dip and he would need to analyze that further. Member Ardiel noted that in 2022, people were coming back from the pandemic, and that we are likely getting back to our normal pre-pandemic numbers. Member Ardiel noted she would anticipate more tourists are coming again which is great, and that the numbers for incidences might increase with the increase of people in the area.

Chair Oliver noted that for intimate partner violence, there is no data point gathered specifically and he has had information provided around the concept of designating intimate partner violence and femicide. Chair Oliver asked if the OPP corporately was trying to address this in terms of identifying femicide within the definition of intimate partner violence. Detachment Commander Licharson noted he cannot speak to corporately how the OPP stands on that issue, and that the detachment and OPP across the Board takes intimate partner violence seriously and has stringent policies around this. Detachment Commander Licharson noted their detachment has created an intimate partner violence response role and the OPP has a designated role for this to provide expertise and support for ongoing investigations. Detachment Commander Licharson noted that taking a proactive role in connecting with local groups such as the Women's Shelter is important. Detachment Commander Licharson noted in their detachment area the number of assaults did increase, including with regard to calls for service for intimate partner violence. Detachment Commander Licharson noted that they are doing a better job and collecting and classifying data for this, and for supervision of these occurrences. Detachment Commander Licharson noted that some of the increases they are seeing that the current economic situation and cost of living crisis has led to families not having the options they have had in the past and can result in escalations.

Member Wilson noted that they see a lot of social media for people who are wanted by the police, and asked if that is helpful to use their security cameras for this purpose. Detachment Commander Licharson noted there have been times where OPP staff have been able to resolve investigations with that assistance, and such a case occurred in Bracebridge where a photo was posted on social media and through the comments section OPP staff were able to identify the individual and lay charges. Detachment Commander Licharson noted if citizens have surveillance cameras it is helpful for them to consider participating in the CAMSafe Program. Chair Oliver asked if there has been uptake for the CAMSafe Program in the area, and Detachment Commander Licharson noted that there are now 30 participants in the program, and though the uptake is slow

it is good to see the increase. Member Ardiel noted that the Board could work with the Communications staff to educate and build awareness of this program.
