B.1 Matters arising from March 3, 2021 Large Task Force (if needed)

Vaccinations

- Public Health has designated facility rentals for vaccinations to Grey County for coordination Town staff will reach out to County staff to advise that the Beaver Valley Community Centre is available as a vaccination hub
- Agreed that once vaccination messaging is released from the Health Unit (particularly with regard to the 1-800 sign up number), the Town will also circulate the messaging to residents

B.2 Range of Spring 2021 re-opening COVID-19 Measures being Considered

- Report to Business Improvement Area Board outlining the range of 2021 reopening COVID-19 measures being considered, however, the Business Improvement Area did not achieve quorum
 - Meeting has been rescheduled to March 10 to consider the recommendations within the report
 - Generally, it seems the report has been well-received by the Board of Directors, and the Business Improvement Area is appreciative of the approach of early engagement
- There are other staff reports for a Special Meeting of Council in March 2021 that outline reopening items including: additional staff for community services to provide a level of service that allows for reopening of the Community Centre, paid parking enforcement and by-law considerations, winter trail grooming, events, Arthur Street Parking Lot update, Highway 26 Speed Limit Options which may be jointly presented with Ministry of Transportation staff

- Mayor's messaging will be to continue to exercise caution to ensure the COVID-19 numbers stay manageable
- Mayor Soever pointed to a recent article in Collingwood Today, "Pandemic Zones Highlight Problematic County Borders"

 - It was noted that tight application deadlines might be a deterrent for community groups
 - Recent grant opportunities do not follow similar formats, so a unique application is required by organizations each time they apply
 - Discussed that a grant writing workshop might be helpful for Town businesses and organizations
