## PARKLAND DEDICATION BY-LAW UPDATE

### What is being proposed?

The Town of The Blue Mountains has initiated a review to update and replace its existing [Parkland Dedication By-law 2003-31](#).

Parkland dedication is a tool available to municipalities under Section 42 of the *Planning Act*, which allows for the conveyance of land or the payment of cash-in-lieu for park or other public recreational purposes as a condition of development or redevelopment.

The Town's current Parkland Dedication By-law was approved in 2003. Since then, legislative changes have been made to the Planning Act, and this update is needed to ensure the Town's By-law reflects these changes.

The updated By-law will include new provincially mandated changes and will provide clear rules for how parkland dedication is calculated for different types of developments and land uses. Other updates are also proposed, including exemptions for certain types of development such as on-farm diversified uses, reduced parkland dedication requirements for affordable housing and a simple flat-rate approach for residential severances. The proposed Parkland Dedication By-law applies to all lands within the Town of The Blue Mountains. A key map has not been included in this notice as the proposed amendment applies to the entire municipality.

provide comments on this matter in writing or verbally at the Public Meeting.

Comments at the Public Meeting assist the Town and Council in their decision-making process, so be sure to have your say!

### How do I submit my comments?

**Written Comments** – You are encouraged to provide your comments or questions in writing using email or regular letter mail to the Town Clerk. Written comments received by **Friday, March 27, 2026**, will be read by the Town Clerk at the Public Meeting for the benefit of everyone in attendance and will be included in the record of the Public Meeting. Any submitted comments become part of the **public record**, including names and addresses.

**Verbal Comments** – This Public Meeting is a hybrid meeting, allowing the public to attend the meeting in person or virtually. Those that wish to make verbal comments virtually are required to pre-register with the Town Clerk, no later than five business days in advance of the Public Meeting, by **4:30 p.m. on Tuesday, March 24, 2026**.

Anyone wishing to provide their verbal comments in person at the Public Meeting, can attend the Town Hall, Council Chambers.

### Who Can File an Appeal?

Any person or public body, as defined in Section 1(1) of the Planning Act, may appeal Council's decision to the Ontario Land Tribunal (OLT). To preserve the right to appeal, a person or public body must make oral submissions at a public meeting or written submissions to Council before the by-law is passed.

If a person or public body does not make oral submissions at a public meeting or written submissions to Council before the by-law is passed, a person or public body may not be added as a party to the appeal hearing unless the Tribunal determines there are reasonable grounds to do so.
