
What is being proposed?

The purpose of this application is to consider a request for minor variance from the Residential R1-3-62 zone provisions of Zoning By-law 2018-65.

The application seeks relief from General Provision 4.12, entitled, *Decks*, to permit a maximum projection of 3.8m into a required rear-yard setback, whereas a maximum of 1.5m is permitted for an unenclosed deck.

The effect of the application is to permit an unenclosed deck to be setback 5.7m from the rear-lot line.

The legal description of the lands is Lot 22, Registered Plan 16M-64.
