Deputy Mayor Potter called the meeting to order at 9:00 a.m. with Mayor Soever and Councillor Sampson present.

Town staff present were Chief Administrative Officer Shawn Everitt, Director of Operations Shawn Carey, Manager of Communications and Economic Development Tim Hendry, and Administrative Assistant Committees of Council Kyra Dunlop.

B. Deputations

B.1 Deputations, if any

B.1.1 Devin Campbell, Plenary Group

Re: Financing for Municipally-led Partnerships

NOTE: Devin will be attending to answer Task Force member questions, but will not be providing deputation material

Deputy Mayor Potter introduced and welcomed Devin Campbell, Assistant Vice President of Plenary Group, and Catherine Jones, Plenary Group, to the meeting.

- Deputy Mayor Potter provided an overview of the work the RABIT Task Force had undertaken to date since June 2020 and advised that no funding has been received from SWIFT.
- Deputy Mayor Potter provided an overview of the challenges facing the community in rural access to internet.

Manager of Communications and Economic Development Tim Hendry joined the meeting at 9:10 a.m.

- Devin provided the Task Force with an introduction of Plenary Group as a P3 model based on long-term investments, and noted an approximate term of 30-50 years for pay-back. Investors included in Plenary Group's portfolio include life insurance companies and pension investments. Devin noted that many municipalities do not want to get into system ownership, and enquired as to the need for the municipality to own its own network.
- Devin advised that with the Town being on the cusp of 8,000 households, with anchor institutions and large agricultural anchor tenants that would put the Town in a good position
- Plenary Group typically invests in projects that are a minimum of \$10,000,000 to \$15,000,000
- Devin advised that to reduce costs that the Town should be installing empty conduit anytime roads or infrastructure is being revitalized.
- Director of Operations Shawn Carey noted that the Town currently has Access Agreements in place with providers, and that Variance Agreements are currently being considered to place conduit at the side of the road.
- Devin provided his recommendation for the next steps being finding out what a
 municipally owned conduit would like, that this information could be found
 without hiring consultants and that the Town should like at its own assets and
 capital projects.

Deputy Mayor Potter thanked Devin and Catherine for their presentation.

Tim Hendry advised that just over 1,400 tests have been completed and that the majority of the tests seem to be on the shoreline. He noted that there have been some challenges with testing, being that residents are not necessarily conducting multiple tests and completing those tests at different times, and that there are very few tests completed by residents in rural areas.

Tim advised that he has received feedback from individuals that cannot complete the test because they do not have internet access at all. Tim advised that they will be adjusting their marketing to address these challenges.

Shawn Everitt and Shawn Carey left the meeting at 10:00 a.m.

Tim noted he will receive a formal quotation from CIRA for detailed data analysis to be provided at the following Task Force meeting.

Tim Hendry left the meeting at 10:01 a.m.

Deputy Mayor Potter noted that the discussion went well and had led to additional information. He noted that they heard from Grey Highlands Chamber Stuart Halliday, who may attend a future meeting.

Councillor Sampson noted that the mapping of the backbone of the conduit infrastructure could be brought to the University of Guelph.

Mayor Soever noted that a feasibility study should be done and that the Town should use the analogy of water/sewer systems to explain the potential municipally-owned model. He noted that the plan could be developed by the University of Guelph project.
