- Internet Speed Test Challenge
  - Tim Hendry emailed to advise he would be unable to attend and it was requested that he provide an update to the Task Force by email following the meeting.
  - Mayor Soever noted that there were a number of areas still missing in the data collection and that issues persisted regarding the Speed Test Challenge icon placement and its indication of location. Deputy Mayor Potter has spoken to CIRA about the mapping glitch.
- Installation guidelines for conduit in The Blue Mountains Road Allowance ("Variation Agreement")
  - Director of Operations Shawn Carey advised that a draft policy was being discussed in the Senior Management Team
  - Frustration has been expressed by a local provider regarding the draft Variation Agreement and also with respect to ICON grant applications
  - Consideration for Town-owned conduit discussion. Shawn Carey noted that Town staff would continue to review the engineering standards and would be bringing a report to Council in fall 2021.
  - Shawn Everitt noted that a resolution from the Task Force to Council could be made and that a motion could be brought forward through the budget process. Shawn Everitt asked if there was an intention of the Task Force that non-internet service providers utilizing Town property are also charged.
- Eh!Tel and GBTel Inc. Universal Broadband Fund Proposals
  - Eh!Tel and GBTel advised that they do not expect to hear back regarding the proposal until mid-summer 2021

- R2B2 and the Town of The Blue Mountains
  - Executive Assistant Sarah Merrifield advised R2B2 representatives will attend the June 7, 2021 meeting and materials will be circulated to Task Force members in advance of the meeting.
- Telecommunications Memo from PDS
  - Deputy Mayor Potter noted that he had a conversation with Stewart Halliday, Grey Highlands Chamber of Commerce, regarding their interest in the RABIT Task Force work and that they may attend an upcoming meeting. Deputy Mayor Potter advised that Stewart is waiting to hear from Waterloo University regarding a long-term project that may also serve the interests of the RABIT Task Force.

#### **C.4 Intelligent Cities Summit Presentation – Impact of Infrastructure Planning on Smart City Development**

Mayor Soever noted that a dedicated staff person would be required to oversee this internet project.

Shawn Everitt left the meeting at 9:57 a.m. to attend another meeting.

- Need to build a digital infrastructure inventory; and
- Summary: Role of connectivity in the municipal context.

Deputy Mayor Potter thanked Mayor Soever for the presentation. Deputy Mayor Potter noted that the same themes are present in the external presentations, being that they provide a clear picture that building a strategy will be key and that they will need someone to implement the project.
