
What is being proposed?

The purpose of this application is to consider a request for minor variance to the "Accessory Apartment" provisions of General Provision 4.1 of Zoning By-law 2018-65. The following variances are requested by the applicant:

- Relief from General Provision 4.1.2(g) to permit the use of an additional driveway for an accessory apartment, whereas the use is required to share the same driveway as the main dwelling unit; and
- 2. Relief from General Provision 4.1.3(c) the permit an accessory apartment to be located 57m from the main dwelling unit, whereas the use is not permitted to be located more than 50m from the main dwelling unit.

The effect of the application is to permit the construction of an accessory apartment unit on the lands which is located 57m from the main dwelling unit and utilizes a dedicated driveway entrance.

The legal description of the lands is Concession 11, Part Lot 24, 16R-3962, Part 4, 16R-5223, Part 1, and 16R-9577, Part 1.
