A. Recommendations

THAT Council receive Staff Report FAF.21.127, entitled “2022 Municipal Election, Selection of Method of Voting”;

AND THAT Council direct that Electronic Voting – Internet and Telephone Voting, be approved as the voting method for the 2022 Municipal and School Board Election, and direct staff to provide a by-law to a future meeting of Council for enactment.

B. Overview

This staff report is seeking Council direction on the preferred method of voting for the 2022 Municipal Election.

C. Background

This staff report is provided further to Staff Report [FAF.21.042 "2022 Municipal Election - Alternative Voting Method & Use of Vote Counting Equipment"](#) wherein Council directed staff to complete a survey to receive input from the public as to the preferred method of voting for the 2022 Municipal Election.

D. Analysis

The *Municipal Elections Act* permits municipalities to make use of alternative voting methods and vote-counting equipment such as voting machines, voting recorders or optical scanning vote tabulators for Municipal and School Board elections. Council is required to pass a by-law by May 1, 2022 setting the method and manner of voting, it being noted that a hybrid voting method is also an option available to Council.

The survey to receive input from the public on the preferred method of voting was open from May 3, 2021 to June 1, 2021. Attachment #1 is the “2022 Municipal Election – Voting Methods, Survey Response Report”, noting 322 responses. In response to the question asking for a

ranking of the preferred method of voting, it is noted that the preferred method of voting is Electronic Voting, with the options listed below in ranked order:

1. Electronic Voting (Online)
2. Vote by Mail
3. In Person (Paper Ballot)
4. Telephone Voting

The survey also included the following questions, and a summary of the responses received are listed below:

Q6 “Are there any barriers preventing you from voting in the 2022 Election”.

- travel plans
- COVID or pandemic
- work commitments (shift work)
- unreliable internet
- accessibility (mobility)

Q7 “Please provide any additional comments regarding your preferred methods of voting”

- Due to COVID pandemic, electronic voting is preferred
- Provide multiple options to allow electors to vote if unable to attend in person
- The cost of paper ballots, printing, waste of paper
- Provide several advance voting dates
- Electronic is quick and easy, provides a quick tally
- Request stronger guarantees and stronger contractual penalties if doing electronic voting
- Vote by mail is too costly, prefer to drop the ballot off
- Telephone was convenient because of mobility
- Too many options to vote will increase the cost
- Need early and good education public information process to advise electors
- The opportunity for connection at the Town Hall and Community Centres is imperative to our communities to be able to see and talk to staff, and present ourselves in person is a constitutional right.
- In person increases travel time and environmental impacts, more staffing required

Based on the comments received through the election survey, and the comments of Council, staff are recommending a “hybrid” voting method to provide more than one method of voting, similar to that offered in the 2018 Municipal and School Board election, being electronic and telephone.

Staff believe that electronic and telephone voting satisfies any concerns of the public and staff relating to the current or any future pandemic as it reduces the number of staff required to conduct the election, reduces touchpoints between electors and staff, and reduces the number of in-person interactions between the public and staff.

In the 2018 election, electors had the option to vote by telephone, electronically, or in person at the Town Hall during the advance voting period when the Town Hall was open during normal office hours, or during specific extended periods. Allowing electors to vote in the Town Hall satisfied the need or wish of those that preferred to vote in person, and/or required assistance to be able to vote electronically or by telephone. Allowing electors to vote electronically or by telephone also allowed those that were not on the voters list or had misplaced their voter kit, an opportunity to be added to the voters list, and be able to vote. Staff confirm that numerous calls were received in the days leading up to the election, and also on election day, from those that had misplaced their voter kit, or were not on the voters list, and were unable to attend the Town Hall to obtain a replacement voter kit. Subject to the process established by the Clerk's office, these electors were able to receive their voter kit electronically, and allowed them to vote.

Changes to the *Municipal Elections Act*

[Bill 218](#), an Act to enact the Supporting Ontario's Recovery Act, 2020 to amend the *Municipal Elections Act, 2020* received Royal Assent November 20, 2020 and made a number of changes to the *Municipal Elections Act*, including the date on which a by-law is required to be passed to establish the method voting. The changes to the *Municipal Elections Act*, effected by Bill 218 are noted below:

1. Deadline to pass a by-law setting the method and manner of voting is now May 1 in the year of the municipal election (May 1, 2022).
NOTE: the 2018 municipal election deadline was May 1 in the year prior to the municipal election (May 1, 2017).
2. Deadline to publish election procedures is moved to June 1 in the year of the election (June 1, 2022).
NOTE: the 2018 municipal election deadline was December 31 in the year prior to the election (December 31, 2017)
3. Nomination Day is now the third Friday in August (August 19, 2022)
NOTE: Nomination Day in the 2018 municipal election was the fourth Friday in July (
4. Removal of the option for ranked ballot voting

Question on the Ballot

Council requested information regarding the inclusion of a question on the ballot. The *Municipal Elections Act* states that Council of a municipality may pass a by-law to submit a question to the electors by March 1 in the year of the election, subject to a specific process as outlined in the *Municipal Elections Act*. The results of a question authorized by by-law are binding upon the municipality if at least 50% of the eligible electors have voted on the question, and if more than 50% of the votes on the question are in favour of those results.

The relevant sections of the *Municipal Elections Act* are provided below for reference:

Submission of by-laws and questions

- 8(1)** The council of a municipality may pass a by-law to submit to its electors,
- (a) a proposed by-law requiring their assent;
 - (b) subject to section 8.1, a question not otherwise authorized by law but within the council's jurisdiction;
 - (c) subject to section 8.1, a question, the wording of which is established by an Act or a regulation under an Act.

Notice to electors

Conditions re: submitting a question

- 8.1(1)**A by-law to submit a question to the electors under clause 8 (1) (b) or (c),
- (a) shall be passed on or before March 1 in the year of a regular election at which it is intended to submit the question to the electors;
 - (b) cannot be amended after the last date referred to in clause (a); and
 - (c) despite clause (b), can be revoked on or before nomination day and, if the election does not include an election for an office, on or before the 31st day before voting day.

8.1(2) A question authorized by by-law under clause 8 (1) (b) shall comply with the following rules:

1. It shall concern a matter within the jurisdiction of the municipality.
2. Despite rule 1, it shall not concern a matter which has been prescribed by the Minister as a matter of provincial interest.
3. It shall be clear, concise and neutral.
4. It shall be capable of being answered in the affirmative or the negative and the only permitted answers to the question are "yes" or "no".

Notice of intent

- (3) Before passing a by-law under clause 8 (1) (b) or (c), the clerk shall give at least 10 days notice of the intention to pass the by-law to the public and the Minister and hold at least one public meeting to consider the matter.

Notice of by-law

- (4) Within 15 days after a municipality passes a by-law under clause 8 (1) (b) or (c), the clerk shall give notice of the passage of the by-law to the public and the Minister.

Contents

- (5) A notice under subsections (3) and (4) shall include,
 - (a) the wording of the question;

- (b) in the case of a by-law under clause 8 (1) (b), a clear, concise and neutral description of the consequences of the question if it is approved and the consequences if it is rejected with the special majority under section 8.2, including an estimate of the costs, if any, that the municipality may incur in implementing the results of the question; and
- (c) in the case of a by-law under clause 8 (1) (b), a description of the right to appeal under subsection (6) including, in the case of a notice under subsection (4), the last day for filing a notice of appeal.

Results

8.2 (1) The results of a question authorized by a by-law under clause 8 (1) (b) are binding on the municipality which passed the by-law if,

- (a) at least 50 per cent of the eligible electors in the municipality vote on the question; and
- (b) more than 50 per cent of the votes on the question are in favour of those results.

E. Strategic Priorities

1. Communication and Engagement

We will enhance communications and engagement between Town Staff, Town residents and stakeholders

2. Organizational Excellence

We will continually seek out ways to improve the internal organization of Town Staff and the management of Town assets.

4. Quality of Life

We will foster a high quality of life for full-time and part-time residents of all ages and stages, while welcoming visitors.

G. Financial Impacts

The method(s) of voting will result in a financial impact to the municipality. Council budgeted \$62,000 for the 2018 Municipal and School Board election. Currently there is \$53,000 in the Council Reserve for the 2022 Municipal and School Board election, and \$20,000 will be added in 2022 for a total of \$73,000.

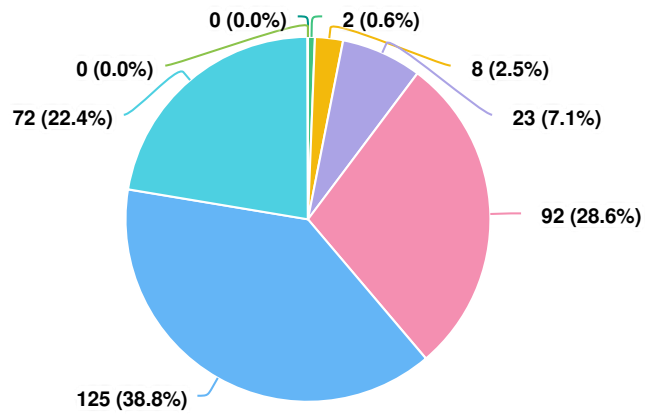

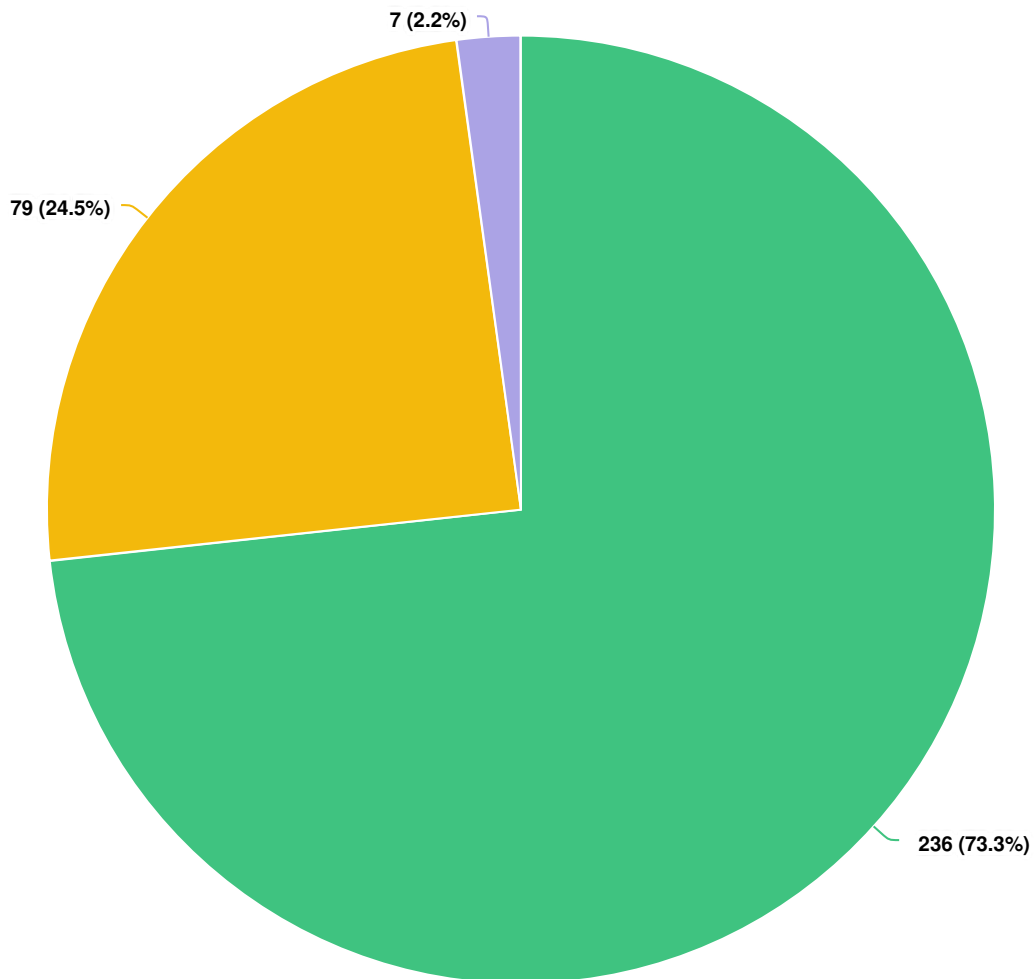

Q2 | Did you vote in the Town of The Blue Mountains 2018 Municipal and School Board Election?

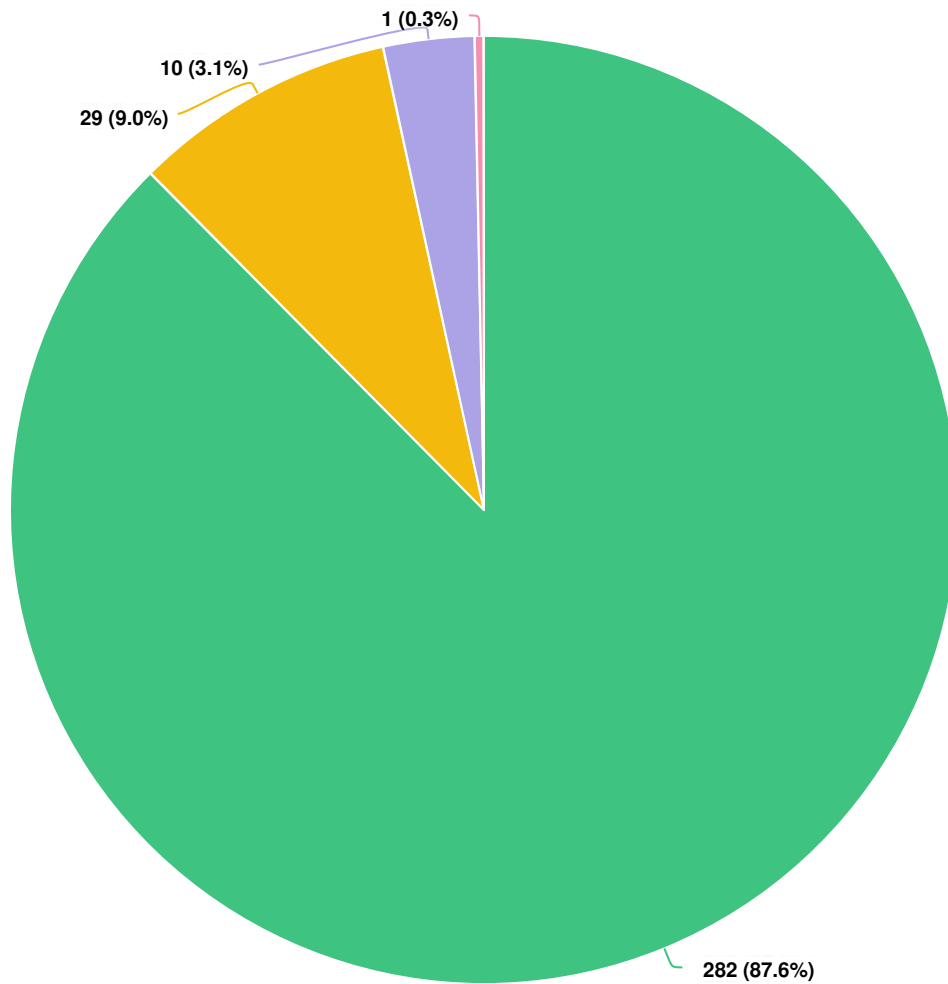

Q3 What type of resident do you consider yourself?

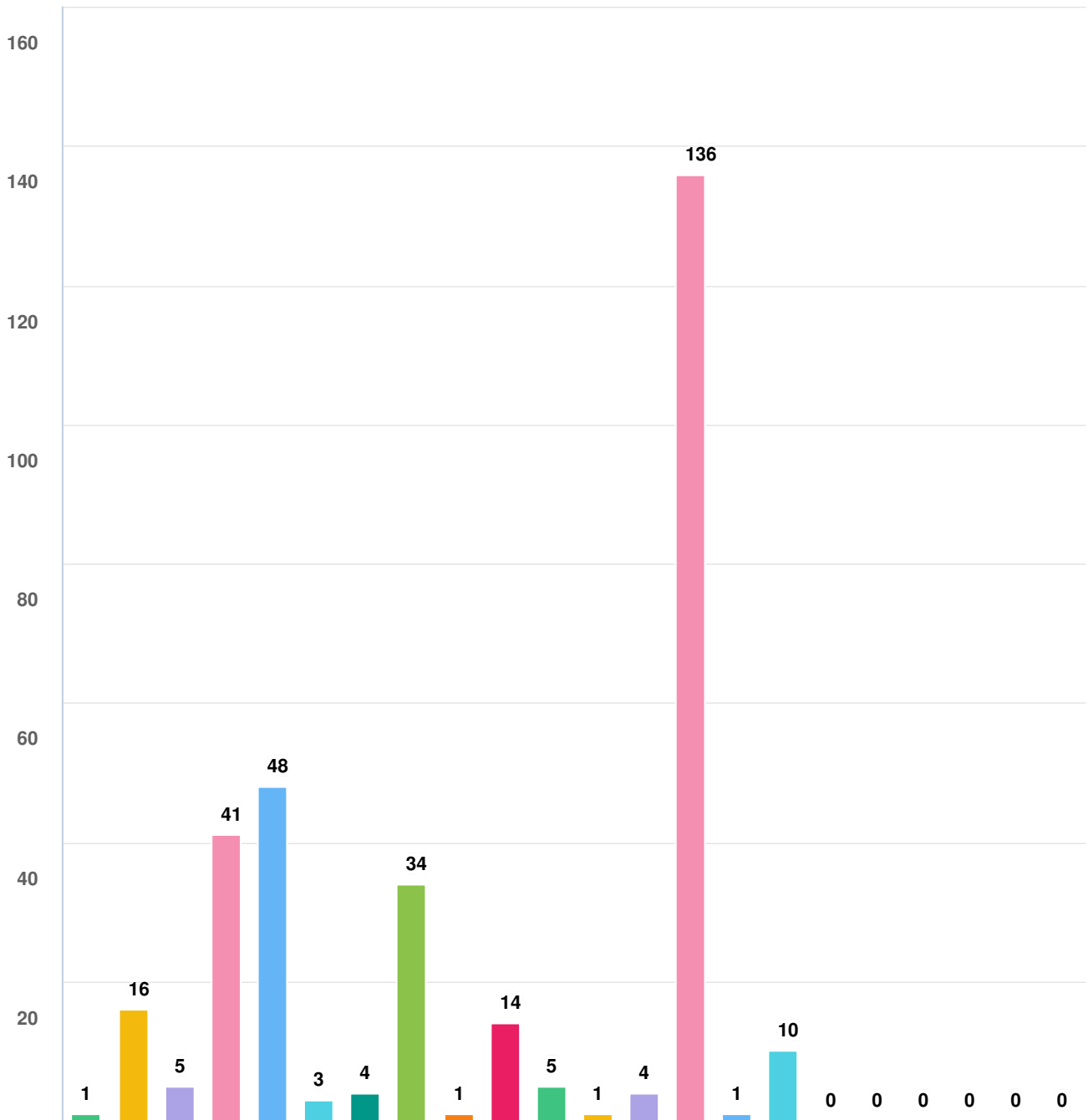
