B. Staff Reports and Deputations

B.1 Grant Street, Canadian Internet Registration Authority Re: The Blue Mountains Internet Speed Test Data Analysis

Grant Street, Canadian Internet Registration Authority provided a presentation regarding The Blue Mountains Internet Speed Test Data Analysis. Grant reviewed mapping for internet speed tests before and after the challenge, for both rural, and built-up areas. Grant provided a summary of test results for Blue Mountain Village Area, Camperdown, Castle Glen, Craigleith/Swiss Meadows, Lora Bay, Thornbury/Clarksburg, and the rural area. Grant reviewed the 50/10 test results and the results where internet provision was less than 5/1, in addition to reviewing the ISED Reported Cable and Wireless Service, as reported by Internet Service Providers.

Councillor Sampson enquired whether there is a way to confirm if the reported test results match what the Internet Service Providers are saying is available in the area – Grant noted a drive map would need to be completed to confirm if test results are due to infrastructure, or an economic decision on the part of the property owner.

Grant provided an overview of the conclusions derived from the Internet Speed Test Challenge, including: most areas in The Blue Mountains need upgraded services; local solutions should be explored; existing funding opportunities are insufficient and take too long; the Town could consider a Public Private Partnership; a Strategic Approach is needed; there might be a possibility of partnering with a Not-for-Profit firm offering turnkey internet solutions. Grant also noted that i-Valley might be an option as well.

Mayor Soever enquired whether any of the current funding opportunities might cover costs associated with putting together a plan for provision of internet.

With respect to cell towers, CAO Shawn Everitt advised that the Town has participated with University of Guelph's R2B2 program representatives – the recommendation arising from that group is to ensure that any cell tower applications include fibre technology and screened to see if the company applying for the tower already has proponents reserving space. These types of parameters can be engrained into the Telecommunications Policy. Grant noted that there are companies that will build cell towers on specification which then allows proponents to add their technology to the towers.

The Task Force requested that Grant attend the August 9, 2021 Council meeting to present the data analysis to Council.

Deputy Mayor Potter provided an overview of the Task Force Report that is being submitted to Council August 23, 2021. Included with the Report will be a motion to request Council to extend the mandate of the Task Force for an additional year. Councillor Sampson offered to create a decision tree to accompany the Report. Executive Assistant Committees of Council confirmed the Report is due to Clerks office by August 16, 2021.
