B. Staff Reports and Deputations

B.1.1 Grant Street, Canadian Internet Registration Authority, Barry Gander and Terry Dalton, i-Valley Re: Broadband for The Blue Mountains

Deputy Mayor Potter welcomed Grant Street of CIRA, Barry Gander, and Terry Dalton of i-Valley who provided a presentation on broadband for The Blue Mountains.

Barry and Terry provided a team introduction and noted the potential exists in The Blue Mountains for an open-access, community network, which is a network not owned by the telecommunication companies. It was noted that The Blue Mountains is underserved with its current internet availability, and lack of internet can translate into lack of healthcare, security, and population. It was noted that people are preferring to move to rural areas, provided that reliable internet service is available.

The group reviewed CIRA Internet Speed mapping data for South Georgian Bay region and The Blue Mountains.

i-Valley representatives clarified the six step pathway to community broadband networks, beint: demand assessment, detailed budget and design, consolidation of data and options for report to the Town, arrangement of funding, sign funding agreements, and provide monthly updates. Community-based networks have different goals than traditional telecommunication company-based networks. Community-based network goals include: job creation and innovation, new and staying businesses, quality of life, and secured/higher tax revenue. I-Valley did note however that telecommunication companies still have a role to play in community-based networks.

The design approach for community-based networks includes leveraging current assets like hydro poles to create a backbone, and use wireless in areas where fibre is not feasible.

It was noted that a Request for Information could be issued followed by a Request for Proposal process for community-based network solutions and/or a Digital Infrastructure Plan.

The community-based network is governed and operated at the community level and any service provider can utilize the network. Users pay a monthly usage fee. Community-based networks can be funded through Public Private Partnerships and Provincial and Federal Funding.

It was noted that a community network can be built in a decade in most communities.

Deputy Mayor Potter thanked CIRA and i-Valley representatives for the presentation.
