What is being proposed?


The purpose of this application is to consider a request for minor variance from the Residential Zone Standards for R1-1 of Zoning By-Law 2018-65.

The effect of the application is to permit a attached garage to be located closer than 2 m from the side yard zone standard. A setback of 1.0 m from the interior side lot line is proposed for the attached garage.
