

### What is being proposed?


The purpose of this application is to consider a request for minor variance from the Residential Zone Standards for R1-1 of Zoning By-Law 2018-65.

The application seeks relief from the R1-1 Zone Standard which requires a maximum lot coverage of 30% The proposed single dwelling has a lot coverage of 33%.

The effect of the application is to permit the proposed single dwelling to cover 33% of the lot area.

The legal description of the lands is Unit 3 Lot 3 16M-24 Block 3 RP 81.
