C. Matters for Discussion

C.1 Protocols/Adaptive Operations for Winter Season – All Task Force members, and Svetislav Milanopulus, B.A.Sc., CPHI(C), Public Health Inspector, Grey Bruce Health Unit

A) Input from Grey Bruce Health Unit

NOTE: The following questions were provided to Mr. Milanopulus in advance of the meeting:

- 1) Can you comment on the effectiveness of face shields rather than masks? Particularly for waitstaff.
 - Face shields are not a like-for-like substitute for a mask, as they do not filter out respiratory droplets
 - Face shields are, however, better than nothing
 - Mr. Milanopulus noted some individuals are unable to wear even a face shield due to an underlying medical condition, such as anxiety
- 2) Our region is one of the primary winter destinations in Ontario for outdoor activities & attractions. What support & flexibility on current provincial restrictions can we expect to see from the province for winter tourism? More importantly, what role will Grey Bruce Public Health play to advocate for winter tourism businesses to open their full experience despite these restrictions. Specifically, advocating for businesses that have already invested in safe operations and strict health protocols as they manage significantly reduced capacity levels, staff employment and revenue potential.
 - Administrative and engineering controls are in place to allow for safe operations however, Grey Bruce Public Health is not actively promoting tourism or visitors within the region; safe operations do not equate to promotion of tourism
 - Mr. Milanopulus noted the recent advice from the Province to discourage visitors from high traffic to low traffic areas
 - Noted saunas/steam rooms are to remain closed, per Provincial direction

B) Line/Capacity Management

- 1) Best practice for managing line ups in an outdoor environment when there's snow on the ground?
 - Public Health Grey Bruce will source best practices and follow-up
 - Discussed that any solution must adhere to fire route restrictions, etc.
- 2) Blue Mountain Village capacity management for ski hills?
 - Andrew Siegwart noted plans are still being finalized, but include: pass sales will be promoted over day ticket sales, plan ahead, purchase in

advance, promotion of off-peak visitation, full use of public spaces with outdoor warming areas

- 3) Town of The Blue Mountains Recreational Spaces
 - Mayor Soever noted he has contacted Ministry of Environment, Conservation, and Parks to confirm if access is possible to Craigleith Provincial Park for winter recreational purposes
- 4) Provision of capacity management throughout the municipality
 - Requested continued weekly calls between trading areas and business associations to discuss capacity expectations, which includes an initial planning session, similar to the coordination throughout summer 2020
 - Director of Community Services Ryan Gibbons noted Grey County is initiating discussion with large public land owners to confirm if applicable properties can be opened for recreational potential

C) Glove Wearing Health and Safety Protocols

- 1) Wait staff do not need to be gloved
- 2) Encourage patrons wearing mittens/gloves in retail environments during the colder months to keep the gloves on their person to avoid cross-contamination

D) Town Scenarios Should the Government of Ontario go into Further Lockdown

- Emergency Controls Group
 - Haven't had any crisis issues at the Emergency Control Group level
- LE Shore Memorial Library Winter Plans
- Municipal Facilities
 - Re-opening of municipal facilities and review scenarios as it happens
 - Fall 2020 focus has been recreational programming at community centres
