#### D. Matters for Discussion

#### D.1 Expansion of Owen Sound Family Health Team

Chair Porter advised that as part of their strategic plan for 2022 the Owen Sound Family Health Team would be looking to expand into Meaford, Town of The Blue Mountains and Grey Highlands. The Family Health Organization, which included Meaford, Town of The Blue Mountains and Grey Highlands would be making an application to the Owen Sound Family Health Team at their April Board meeting. Councillor Sampson noted that Meaford Council had endorsed the concept and that Town of The Blue Mountains would have to make a similar recommendation at their Council.

The Committee members discussed how best to procedurally support the Family Health Organizations application to the Owen Sound Family Health Team and it was noted that many physicians want to join family health teams in order to have referrals to local resourcing be close by. Chair Porter noted that the expansion of the Owen Sound Family Health Team was a win for the area and for residents.

The Committee discussed whether financial support would be needed at this time. It was noted that their make be a request in future to assist with the business case assessment which would identify services offered through the expansion of the Owen Sound Family Health Team.

WHEREAS the Ministry of Health has long declared the Municipality of Grey Highlands, Municipality of Meaford, and the Town of the Blue Mountains to be a designated Area of High Physician Need there has been no new net Family Physicians in the last ten years; and

WHEREAS the recent Census data which has confirmed an unprecedented growth of 3,479 residents in the aforementioned areas has only added to a shortage of ten Family Physicians for the now approximately 10,000 unrostered patients; and

WHEREAS a Family Health Team provides primary care by a team of family physicians, nurse practitioners, registered nurses, social workers, dietitians, and other professionals who work together to provide primary health care for their community; and

WHEREAS the Family Health Team model is also known to be the preferred practice setting for new graduating Family Physicians to set up a rural practice in our community;

THEREFORE be it resolved that the Joint Municipal Physician Recruitment and Retention Committee supports the Family Health Organizations' application to the Owen Sound Family Health Team to better serve the residents of those respective communities;

AND THAT the Committee requests that this recommendation be considered at the March 28, 2022 Town of The Blue Mountains Council meeting due to its time sensitive nature.
