If there is an appeal to the Ontario Land Tribunal, except where all appeals are withdrawn, a hearing will be held and notice will be given to the Applicant, the Appellant, the Secretary-Treasurer of the Committee, and to anyone else as determined by the Ontario Land Tribunal.

If no appeal on this decision is received within twenty days of the decision, the decision of the Committee is final and binding. The Secretary-Treasurer will notify the Applicant and file a certified copy of the decision with the Clerk of the Town of The Blue Mountains.

**Property Location:** 39 Alice Street (Plan 107 Part Lot 8 Registered Plan 16R-2268 Part 1)

**Owner/ Applicant:** Stewart

**Purpose of Application:**

The purpose of this application is to consider a request for minor variance from R1-1 zone standards in Zoning By-Law 2018-65. The application requests the following variance:

1. Relief from R1-1 zone standard to permit a maximum lot coverage of 36%;
2. Relief from R1-1 zone standard to permit a minimum setback of 5.47 from the front lot line; and
3. Relief from General Provision 4.13 to permit a covered porch to project 2.26 metres into the exterior side yard.

The effect of the application is to permit the construction of a detached garage, covered porch, vestibule and addition to the single dwelling.

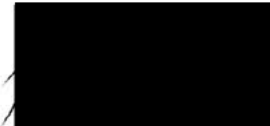

CONDITIONS:

1. That the development be constructed in a manner substantially in accordance with the applicant's submitted site sketch; and
2. All homeowners and/or contractors digging on site get the required Locates completed at the property prior to digging; and
3. This variance to the zoning by-law is for the purpose of obtaining a building permit and is only valid for a period of two (2) years from the date of decision, should a building permit not be issued by the Town within two years, the variance shall expire on April 19, 2024.

REASON FOR DECISION:

The Committee is satisfied that the application meets the four tests for minor variance of S.45. (1) of the Planning Act, as noted in the Planning and Development Services Staff Report PDS.22.041.
