### Application for a Variance to Sign By-Law 2016-71

Property Location: 54 King Street East

Public Meeting: July 20, 2022 at 1:00 PM Hybrid Format  
(In-Person AND Virtual/Online)

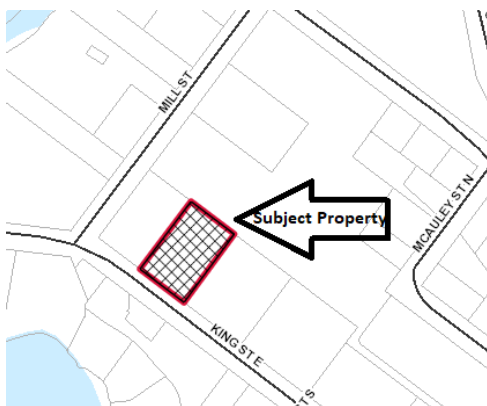
### What is being proposed?

The Town of The Blue Mountains has received an application for a variance to Municipal By-law 2016-71. The application proposes relief to allow a Digital Display Sign to exceed the 0.5 square meter allowance to allow the sign to be 0.93 square meters. Additionally, the application proposes relief to allow a Digital Display Sign to be within the 300 meter minimum distance from the road to allow the sign to be 10 meters from the road.

Relief from the following sections of By-law 2016-71 as included in the application:

- 1) Relief from Section 4.7 (1) to allow the sign to be 0.93 square meters whereas the requirement is 0.5 square meters.
- 2) Relief from Section 4.7 (2) to allow the sign to be 10 meters from the side of the road whereas the required distance is 300 meters.

Anyone wishing to provide their verbal comments in person at the Public Meeting, can attend the Town Hall, Council Chamber. Those providing their comments in person, are required to follow the Public Health Guidelines of the Town, as recommended by the Grey Bruce Health Unit.
