#### C. Matters for Discussion

#### C.1. Accelerated High Speed Internet Program Request for Proposal Update

Mayor Soever advised that Town staff were in contact with the Ministry of Infrastructure and expected a response in April 2022 regarding the successful AHSIP bidder on Block 51.

#### C.2 Ontario One Call Locates

Director of Operations Shawn Carey introduced Locate Technician Dean Easterbrook. Dean ensures the Town is compliant with Ontario One Calls. Dean provided an overview of a webinar he had attended regarding One Calls and how Bill 93 would impact the Town. Dean noted that there were two key take-aways from the webinar:

- 1. Companies who delay their locates will be penalized. This was meant to ensure companies were properly staffed to complete work.
- Dedicated locaters could be used in the Town on big projects and could have 10 days to complete locates rather than 5 days.

The Task Force members discussed the option of charging companies for locate services if the Town had to conduct a locate in their area.

The Task Force discussed how to provide comments to the Ministry of Infrastructure on Bill 93. Dean noted he would circulate the contact information provided through the webinar to the members. Councillor Sampson noted that the Task Force should connect with Bob Bailey, Minister for Provincial Parliament Sarnia-Lambton as it was his private members bill that created One Call.

CAO Everitt joined the meeting at 10:20 a.m.
