Mayor Soever called the meeting to order at 2:31 p.m. with Councillor Sampson and Councillor Bill Abbotts.

## **C. Matters for Discussion**

---

### **C.1. Accelerated High Speed Internet Program (AHSIP) Update**

Mayor Soever provided an overview of correspondence sent between himself and the Ministry of Infrastructure, and staff correspondence to the Ministry of Infrastructure. Mayor Soever noted that a copy of those correspondences would be circulated through the Minutes of the meeting for review. Councillor Sampson noted that a follow-up correspondence to the newly sworn in provincial cabinet ministers could be beneficial.

### **C.2 Engineering Standards Update – Director of Operations Shawn Carey**

Director of Operations Shawn Carey advised that the Engineering Standards would be finalized by September 5, 2022 and that staff would be connecting with the development community for their input as well.

### **C.3 County Road Conduit Update – Chief Administrative Officer Shawn Everitt**

Mayor Soever noted that he had heard that Grey County was only putting conduit in at intersections. Director Carey advised he would follow-up with the County and report back to Task Force members.

Chief Administrative Officer Shawn Everitt joined the meeting at 2:45 p.m.

  - Director Carey advised that there were some changes to the Ontario One Call program and that Town staff were reviewing the potential of having their own certified dedicated locater employed through the Town.

  - Request for Proposal has been drafted and staff were in the process of finalizing it to bring forward.

## **C.5 Follow-up Direction from Council**

**Note: The following recommendation was considered by Council on April 12, 2022:**

THAT Council of the Town of The Blue Mountains receives the April 6, 2022 Rural Access to Broadband Internet Technology RABIT Task Force recommendation as follows:

THAT the Rural Access to Broadband Internet Technology RABIT Task Force requests that Council consider passing a motion requesting that Grey County provide an update on how the Grey Road 2 and Grey Road 13 projects confirm with the Official Plan under Section 8.9.4(3), as follows:

“When reconstructing County roads or the CP Rail Trail, the County will consider installing fibre or conduit for future fibre to connect with the overall fibre network. Local municipalities are also encouraged to install fibre or conduit when reconstructing roads. The County in consultation with local municipalities, telecommunication providers, and SWIFT will develop a fibre/conduit specification for the installation of fibre and conduit. An ownership model will also be developed in consultation with SWIFT.”

AND THAT the above recommendation be considered at the April 11, 2022 Council meeting due to its time sensitive nature, CARRIED.

**Note: The following recommendation was considered at the April 25, 2022 Council meeting:**

THAT Council of Town of The Blue Mountains receives the February 17, 2022 Rural Access to Broadband Internet Technology Task Force recommendation as follows:

THAT the Rural Access to Broadband Internet Technology RABIT Task Force requests that Council renew the CIRA Internet Performance Test with Grant Street with funds allocated from the RABIT Task Force budget, CARRIED

AND THAT Council of Town of The Blue Mountains renews the CIRA Internet Performance Test with Grant Street with funds allocated from the RABIT Task Force, CARRIED.

Mayor Soever provided an overview of the motions passed at Council. CAO Everitt noted that Grey County had reached out to Bruce Street Technologies on road improvements being made at Grey Road 2 about installation of conduit and that there was hope that the County would take the same approach to Grey Road 13. CAO Everitt advised that the funding to continue the CIRA Internet Performance Test had been completed and that staff would work on the CIRA Testing with Grant Street.

CAO Everitt left the meeting at 3:00 p.m.

### **D.1 Amit Gupta Re: Swiss Meadows Access to Broadband**

Mayor Soever provided an overview of the correspondence.

Director Carey advised that staff were looking into the connectivity issues in the Swiss Meadows area. Director Carey noted that because there was so much rock in that area connectivity could be tricky. Staff were working with Bruce Street Technology and noted that at some point the conduit could be redone as the Town would have plans to re-do the water lines in Swiss Meadows. Councillor Abbotts asked if aerial conduit could be used. Director Carey noted that aerial conduit was tricky in rural areas as the poles were either too short or too far apart to accommodate the conduit.
