**4.1. Community Safety and Policing Act, 2019 update**

CAO Skinner advised staff were contacted by the Ministry regarding amending the existing policing contract for another year because the CSPA has not yet come into effect and both Boards and respective Councils should anticipate a report coming forward before the end of the year.

- 4.5. Request for TOBM PSB to contribute towards training for community social service organizations in Equity, Diversity & Inclusion

*Recommendation passed at the June 24, 2022 Collingwood Police Services Board meeting:*

**THAT** the Collingwood Police Services Board allocate up to \$10,000 to deliver training focused on equity, diversity & inclusion to community organizations participating on the Health & Social Service Roundtable which will be delivered by experts in the EDI field of practice.

CAO Skinner noted housing, access to services and mental health support at top priorities in the South Georgian Bay and Springwater Community Safety and Wellbeing Plan which includes Collingwood, and advised that the Collingwood PSB is looking at support the plan by providing funding which would offer training on equity, diversity, and inclusion to not for profit and social service groups in the region. She further noted one of the requests from Collingwood PSB was to seek interest from the TOBM PSB to see if there is the ability to contribute funding towards the training.

Mayor Soever inquired about the EDI training and interest levels from local groups. CAO Everitt advised he will work with staff to see if there is funding available and will provide an update in the next two weeks.
