a. The BMAHC apply for Supplementary Letters Patents to amend the special provisions to remove the requirement for a Council member director to form quorum as follows:

The number of directors which shall form a quorum for the transaction of business shall be five (5) directors of whom one (1) shall be any one of the Mayor, Deputy Mayor or any Councillor of The Town of The Blue Mountains.

The Executive Director and the Chair of the Board of Directors of the BMAHC are hereby authorized to take all such further action(s), as they may deem necessary, proper, convenient, or desirable in order to carry out the foregoing resolution and to fully effectuate the purposes and intents thereof; and
- c. An executed copy of this resolution shall be filed with the minutes.
