Good afternoon Brian,

Based on the submitted documents including the report produced by WT Infrastructure dated March 7, 2022 it is MTO's understanding that the developers will be responsible for all of the construction related costs for any infrastructure being constructed within the MTO highway property limits.

Future maintenance costs will need to be determined through discussions.

Next steps - Formal submission of engineered drawings for MTO review and approval. MTO can review the drawings and provide comments and/or concerns.

For Future Reference:

- An MTO Encroachment Permit will be required for each crossing.
- An MTO Building and Land Use Permit will be required for work on private property. One permit/property.

MTO will have a better idea of permit requirements once the engineered drawings have been submitted for review.
