A. Recommendations

THAT Council receive Staff Report FAF.22.128, entitled "Followup to Public Meeting Re: Proposed Revisions to Council and Committee of Adjustment Procedural By-laws as it relates to Meeting Cycles";

AND THAT, with respect to the Committee of Adjustment Procedural By-law, Council direct staff to bring forth a draft By-law for Council consideration to revise the Committee of Adjustment Procedural By-law 2019-5 to confirm the meeting start time at 1:00 pm, including any associated housekeeping amendments;

AND THAT, with respect to "Council, Public Meetings", Council acknowledges that considering the comments received and the staff recommendations contained in this report, that the "Council, Public Meetings" will be scheduled monthly on a Tuesday, commencing at 1:00 pm;

AND THAT, with respect to the Council and Committee of the Whole meeting cycle, Council direct staff to bring forth a draft By-law for Council consideration to revise the Procedural By-law 2021-76 as it relates to Council and Committee of the Whole meeting cycle, including any associated housekeeping matters, as follows:

Monday, Committee of the Whole commencing at 9:00 am

- Community Services

Tuesday, Committee of the Whole commencing at 9:00 am

- Planning and Development Services

NOTE: When a Committee of the Whole or Council Meeting falls on a Statutory Holiday, the meeting will be scheduled on an alternate date, if required, as approved by Council through approval of the annual meeting calendar.

B. Overview

This report is a follow-up to the August 8, 2022 Public Meeting to receive comments on the proposed changes to the Council and Committee of Adjustment Procedural By-laws.

C. Background

At the July 12, 2022 Special Meeting of Council, Council directed staff to proceed to a public meeting to receive comments on the proposed changes to the Procedural By-laws with a proposed effective date of January 1, 2023.

D. Analysis

As noted in staff report <u>FAF.22.115 Proposed Revisions to Council and Committee of Adjustment Procedural By-laws as it relates to Meeting Cycles</u>, the subject of the August 8, 2022 Public Meeting was specifically related to the meeting cycle and schedules included in the Council and Committee of Adjustment Procedural By-laws.

Committee of Adjustment Procedural By-law:

Comments were received from a current member of the Committee of Adjustment concerned with the proposed 9:00 am start time, and the staff recommendation to move the meeting to the second Wednesday of the month, from the current third Wednesday of the month. Council questioned if the Committee of Adjustment meetings could alternate on a bi-monthly basis from day to evening meetings.

In response to the comments received, staff are recommending that the Committee of Adjustment meetings commence at 1:00 pm, on the third Wednesday of the month. Staff confirm that the 1:00 pm start time on the third Wednesday of the month will not conflict with

other regularly scheduled meetings and provides a consistent meeting rotation for both the public and staff. Continuing with 1:00 pm meetings, allows staff to have access to the IT Department, for internet/recording assistance, if required, with little overtime required.

Council, Public Meetings

With respect to the "Council, Public Meetings", staff recommend that the meetings be scheduled monthly on Tuesdays, commencing at 1:00 pm. Staff confirm that no public comments were received that identify concern with the current afternoon public meeting schedule, or the proposed continued afternoon schedule. Staff confirm that since moving the Public Meetings to the afternoon in 2021, that no comments or concerns have been raised from the public on the afternoon meeting times.

Council and Committee of the Whole Meetings:

Staff confirm that no comments were received from the public in response to the suggested Council and Committee of the Whole meeting cycle. Council members spoke providing the following comments:

- Requested additional information on the number of Council, Committee of the Whole Meetings and Special Meetings scheduled on an annual basis back to 2010, including the scheduled meeting time of those meetings, the number of reports, bylaws and correspondences considered at those meetings
- ii. Concern with the length of the meetings and the number of meetings in this term of Council
- iii. Continuing to allow hybrid attendance is important
- iv. Acknowledged that no comments were received from the public requesting that meetings return to evening meetings
- v. Do we adjust the schedule to have one evening meeting per month
- vi. Consistency in the scheduled meeting time is important and expected by the public
- vii. Was staffing taken into consideration when suggesting that the Council and Committee of the Whole Meetings commence at 9:00 am
- viii. Request for a draft 2023 meeting cycle calendar

Staff have considered the comments received, and in response are providing a summary of the meetings dating back to 2013. Note: the meeting structure changed from Standing Committees to Committee of the Whole in October 2013.

In response to historical meeting schedules, staff provide the following information:

- From 2013 to 2019, the Committee of the Whole meetings commenced at 1:00 pm.
- From 2020 to present, Committee of the Whole meetings commenced at 9:00 am
- Prior to 2020, Council Meetings were scheduled on Monday evenings, commencing at 7:00 pm, and would include Public Meetings

- In January 2020 Council Meetings moved to 5:00 pm start, with Public Meetings at 5:00 pm, and the Council Meeting commencing at 7:00 pm, or immediately following the Public Meetings
- From April 2020, Council Meetings have commenced at 9:00 am
- From January 2022, Council, Public Meetings commenced at 1:00 pm

The number of meetings, and the length of meetings has increased in this term of Council as is demonstrated in the chart below. Staff believe that splitting the Committee of the Whole meeting in to two separate meetings will assist to reduce the length of the Committee of the Whole meeting and will reduce the requirement to schedule Special Committee of the Whole meetings for matters not reached in the regularly scheduled meeting.

The number of correspondences included on Council and Committee of the Whole Agendas has reduced in this term of Council. This reduction is largely due to the inclusion of the clause in the Procedural Bylaw that indicates that correspondences received by the Clerk from municipalities seeking support will be emailed to Council and the Senior Management Team for information and shall be deemed to have been received by Council. Upon review of the correspondence any member of Council or Senior Management Team may request that the correspondence is included on the next Council Agenda for Council consideration. Previously, all such correspondences were included on Council Agendas, for Council consideration.

Staff agree that continuing with hybrid meetings is important for Council, staff and the public. With the increased technology requirements to conduct meetings, including the livestreaming

and virtual attendances and to provide a work-life balance for Council and staff, staff recommend that Council and Committee of the Whole meetings continue to be scheduled at 9:00am. As noted at the Public Meeting, no public comments were received and no requests were received requesting that the meetings be scheduled in the evenings.

As requested by Council, staff have prepared a DRAFT 2023 meeting schedule to demonstrate what the proposed meeting schedule would look like. For comparison, a summary of the number of 2021 REGULARLY scheduled Council and Committee of the Whole meetings, and 2022 "Council, Public Meetings" is provided below, together with the proposed number of 2023 REGULARLY scheduled meetings.

Note: I have used the 2021 Council/COW schedule as the 2022 regular meeting schedule is altered because of the election schedule. I used the 2022 "Council, Public Meeting" schedule as this meeting type did not exist in 2021.

The proposed schedule reduces the number of Council Meetings. The number of Committee of the Whole meetings is slightly higher than the current schedule, though is split between two meeting dates (Administration, Legal and Community Services in one weekly meeting, and Planning, Development and Operations Services in another weekly meeting). Staff believe this schedule will be effective in managing staff's time as staff will only attend the Committee of the Whole meetings where their reports are considered.

With Council's endorsement, an updated 2023 meeting schedule will be provided to Council for approval in a separate staff report.

Following the October 24, 2022 municipal election, the newly appointed Council will have the opportunity to review and make additional updates to the Procedural By-law, if desired.
