Deputy Mayor Bordignon noted that he had gone through each application thoroughly and requested feedback from each of the Committee members regarding the amounts that had been requested from each of the applicants.

The Committee discussed revamping the program for next year to make the process easier for everyone involved including a cap on the amount that any one organization can ask for and having criteria that the Committee will rely on when making these decisions. Deputy Mayor Bordignon noted that the criteria will need to be sent to Council for approval and would have to be communicated to the applicants as well before they could officially use it. Michael Caron noted that last year the Committee had identified criteria to help with determining where and how much of the funds were distributed. Deputy Mayor Bordignon further noted that since the criteria have not been approved by Council they can't officially use them as guidelines but noted that each member could use the criteria personally when the Committee is discussing each application. The Committee went through each item alphabetically and discussed the cash amounts and the subsidies to be given to the applicants. The Committee decided to ensure there was a small amount of money available for the next Council to have available in case there was an emergency request that comes in before the next call out for applications.
