## A. Recommendations

THAT Council receive Staff Report FAF.22.161, entitled "2023 Council and Committee of the Whole Meeting Schedule";

AND THAT Council approve Option #1, Schedule A, as the 2023 Council and Committee of the Whole schedule as attached to Staff Report FAF.22.161.

## **B.** Overview

Council are being presented with three options from which to choose the 2023 Council and Committee of the Whole schedule. The new Procedural By-law will be considered for enactment commencing January 2023.

## C. Background

This staff report is in response to Council's consideration and direction at the September 27, 2022 Committee of the Whole Meeting regarding <u>Staff Report FAF.22.128 Followup</u> to Public Meeting Re Proposed Changes to Meeting Schedules. This staff report seeks direction on the preferred schedule for the 2023 Council and Committee of the Whole meetings.

## D. Analysis

In the development of the attached proposed meeting schedules, staff considered a number of key dates pertaining to municipal conferences and statutory holidays to reduce the number of conflicts and therefore minimize the need to reschedule meetings.

Staff are requesting Council direction on the preferred 2023 Council and Committee of the Whole Meeting Schedule, and offer three Options, as attached to this staff report. Staff recommend proceeding with Option #1, being Schedule A as attached

to this report. Option #1 has the fewest number of conflicts with only 3 conflicting meeting dates with statutory holidays that would require a rescheduling of the meeting and would subsequently result in a more predictable Council and Committee of the Whole schedule to the benefit of the public, Councillors, and staff. In addition the Council summer break in Option #1 is consistent with previous summer breaks. Option #1 has conflicts as follows:

- February 20, 2023 Committee of the Whole falls on Family Day and would be rescheduled to February 27, 2023
- September 4, 2023 Committee of the Whole falls on Labour Day and would be rescheduled to September 11, 2023
- October 9, 2023 Council falls on Thanksgiving and would be rescheduled to October 10, 2023

Option #1 summer break runs from July 12, 2022 to August 11, 2022.

Option #2, Schedule B as attached to this report, has 4 conflicts with statutory holidays requiring a rescheduling of meetings as follows:

- February 20, 2023 Council falls on Family Day and would be rescheduled to February 21, 2023
- April 10, 2023 COW falls on Easter and would be rescheduled to April 17, 2023
- May 22, 2023 COW falls on Victoria Day and would be rescheduled to May 29, 2023
- October 9, 2023 COW falls on Thanksgiving and would be rescheduled to October 10, 2023

Option #2 summer break runs from July 19, 2022 to August 25, 2022.

Option #3, Schedule C as attached to this report, has 5 conflicts with statutory holidays requiring a rescheduling of meetings as follows:

- February 20, 2023 Council falls on Family Day and would be rescheduled to February 21, 2023
- April 10, 2023 COW falls on Easter Monday and would be rescheduled to April 17, 2023
- May 22, 2023 COW falls on Victoria Day and would be rescheduled to Mat 29, 2023
- September 4, 2023 COW falls on Labour Day and would be rescheduled to September 11, 2023
- October 9, 2023 Council falls on Thanksgiving and would be rescheduled to October 10, 2023

Option #3 summer break runs from July 19, 2022 to August 11, 2022.

- Council Public meetings will be scheduled monthly, on a Tuesday, commencing at 9:30 a.m., for the sole purposes of scheduling Public Meetings.
