### A. Recommendations

---

THAT Council receive Staff Report CSOPS.22.077, entitled "Final Draft Transportation Master Plan Follow-up";

AND THAT Council endorse the Final Draft Transportation Master Plan as presented to November 1, 2022 Committee of the Whole with the amendments outlined in staff report CSOPS.22.077.

### B. Overview

---

This report is a follow-up to demonstrate revisions to the Final Draft Transportation Master Plan (TMP) study considering commentary from November 1, 2022 Committee of the Whole and other input to support Council endorsement of the Final Draft TMP.

### C. Background

---

On November 1, 2022 staff presented [Staff Report CSOPS.22.071 Final Draft Transportation Master Plan](#) to Committee of the Whole. Committee of the Whole carried a motion to Council:

*THAT Council receive Staff Report CSOPS.22.071, entitled "Final Draft Transportation Master Plan";*

*AND THAT Council endorse the Final Draft Transportation Master Plan, subject to the lowering of the priority of paving the Georgian Trail, and other commentary as provided at the Committee of the Whole;*

*AND THAT Council direct staff to issue the Notice of Study Completion for the Transportation Master Plan, Carried.*

### D. Analysis

---

Following the November 1, 2022 Committee of the Whole meeting, staff and the TMP study consultant team considered feedback received from Committee of the Whole and other input

toward Council endorsement of the TMP. Attachment 1 details the specific sections and page numbers of the proposed revisions to the Final Draft Transportation Master Plan. As requested by Committee of the Whole, paving of the Georgian Trail has been lowered in priority from Medium to Low.

As indicated in [Staff Report CSOPS.22.071 Final Draft Transportation Master Plan](#) the proposed next steps are to resolve housekeeping items and to issue the Notice of Study Completion.
