Title: Update to By-law appointing Building Inspectors

A. Recommendations

THAT Council receive Staff Report PDS.22.134, entitled "Update to By-law appointing Building Inspectors";

AND THAT Council Direct Staff to include the draft By-law to Appoint Building Inspectors on the next Council Agenda, as attached to Staff Report PDS.22.134, and to repeal the current By-law 2022-25

B. Overview

The existing by-law for the appointment of a Chief Building Official and Inspectors is required to be updated due to staff changes and for emergency preparedness.

C. Background

Subsection 3(2) of the Building Code Act requires the council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the enforcement of the Act in the areas in which the municipality has jurisdiction. The existing By-law 2022-25 is outdated and shall be updated since it no longer accurately contains the names of individuals providing the services as a building inspector for the Town.

D. Analysis

Due to staff changes, the existing by-law shall be updated. The updated by-law will include Christophe Raffy, Dylan Hanson, and Manish Kumar as new inspectors. The updated by-law will continue to contain the names of the existing Chief Building Officials and inspectors listed in the existing by-law, including Building Code consultant, Bill Plewes, and RSM Building Consultants.
