A. Recommendations

THAT Council receive Staff Report FAF.23.030, entitled "Proposed Amendments to the Fees and Charges By-law, Solid Waste Management Fees By-law, and Water and Sewer Charges By-law" for information purposes.

B. Overview

This report outlines the comments from the Public Meeting for the proposed amendments to the Fees and Charges By-law, Solid Waste Management Fees By-law, and Water and Sewer Charges By-law, as well as Staff's response to these comments.

C. Background

The proposed amendments to the Fees and Charges By-law, Solid Waste Management Fees By-law, and Water and Sewer Charges By-law were reviewed as part of the 2023 Draft Budget. On March 7th, 2023, the Town held a Public Meeting to provide the public with the opportunity to review and comment on the proposed amendments to the Fees and Charges By-law, Solid Waste Management Fees By-law, and Water and Sewer Charges By-law.

The 2023 budget process and document included the Fees and Charges for each Department. The draft By-laws were advertised as per the Town's notice policy and included on the Town's website.

Staff are proposing that these By-laws be presented for Council's consideration at the March 27th, 2023 Council Meeting.

The Town received 1 written comment prior to the Public Meeting and the same comment was presented during the Public Meeting. Below is a summary of the comments received from the public.

D. Analysis

The following comments have been received.

Laurey Gillies - Nipissing Ridge Tennis Club

Laurey Gillies has provided Council with comments on the Community Services Fees and Charges regarding the new annual fee for 2023 of a minimum \$1,500 and a maximum of \$2,500 based on annual membership numbers (Attachment #1). Nipissing Ridge Tennis Club is requesting that this fee be modified to a minimum of \$1,000.

Staff Response – Staff welcome direction from Council on where to set this fee for 2023.
