B.15.1 Assumption of Windfall Phase 2C (PDS.21.005)

THAT Council receive Staff Report PDS.21.006, entitled "Assumption of Windfall Phase 2C";

AND THAT Council enact a By-Law to approve full acceptance and assumption of the public works constructed and installed within Registered Plan of Subdivision 16M-57, as well as within Registered Plan 16M-42 Block 43, 54, 55, 61, 62, 65, Carried.

B.15.2 Recommendation Report – Zoning By-law Amendment – 245 Cameron Street (PDS.21.005)

- That the minimum front yard setback for a detached accessory dwelling unit shall be 1.5m;
- That the minimum easterly interior side yard setback for a detached accessory dwelling unit shall be 0.4m;
- That Short Term Accommodation uses, as defined by the By-law, are not permitted on the subject lands, Carried.

B.15.3 P2878 20 Alice Street - Proposed Zoning By-law Amendment (PDS.21.010)-REVISED

Residential Three Exception >(R3-1) zone to permit the use of the lands for residential apartment dwelling units, subject to the following conditions:

- 1. That Table 9.1- Exceptions of Zoning By-law 2018-65 is amended by deleting and replacing the R1-1-1 exception zone provisions as follows:
 - To recognize a 0.0m setback for the existing residential driveway, whereas a minimum setback of 1.0m is required by Part 5.3.1(c) of Zoning By-law 2018-65; and>
 - 2. To recognize an existing width of 4.9m for the existing residential driveway, whereas a minimum width of 6.0m is required by Part 5.1.7 of Zoning By-law 2018-65 for driveways with two-way traffic, Lost.

Whereas the Town receives or commissions or participates in a number of transportation impact studies each and every year, and

Whereas these studies are used to set Town transportation infrastructure policies and priorities and to consider the transportation infrastructure impacts of future developments, and

Whereas these studies use a base data point(s) that are often quite different and rarely coordinated from study to study, and

Whereas there seems to be only casual references in these studies to other prior transportation impact studies in the same general area, and

Whereas in each transportation impact study, there seems to be little attention paid to a comparison of the estimated future impacts that were identified in prior impact studies, and the Town does not have the data readily available to track the accuracy of any of the projections contained in these transportation impact studies, and

Whereas the Town Planning could benefit from requiring the development community to use consistent, accurate, and similarly assembled base line transportation data in their development impact projections, and

Whereas it would be helpful for the Town to use actual real time transportation impact data as it plans and sets a transportation master plan and works with other area municipalities, governmental agencies and Ministries to set transportation policy on a regional basis,

Now Therefore the Transportation Advisory Committee advises Council to:

- 1. Direct staff to work with the Transportation Advisory Committee to hold a physical and or virtual transportation data technology forum (the "Trade Show") in early 2021 (no later than the end of March 2021) whereby transportation data collection technology vendors would present their current data collection and assembly technology to the Town for consideration in any future RFP, and in the preparation of a consistent and reliable transportation Town Database and the Transportation Master Plan, and
- 2. Direct staff to prepare a report on how the Town can require the development industry and others to use this Town Database in the preparation of any transportation impact studies for their individual projects or requests, and
- 3. Direct staff to invite other municipalities in the region to participate in this Trade Show, and begin the attempt to make this Town Database a more regional database. (Carried by Transportation Committee), Carried.
