Winter Gala 2021 Event Details

Discussed that a potential alternative is a "Chase the Ace" style event as COVID-19 restrictions may prohibit a winter gala. Noted that this would need to be coordinated with Grey Bruce Health Services if the Committee agrees to plan it.

Committee members noted several additional alternatives to the winter gala such as: GoFundMe page, winery event or summer beach party (post-COVID-19), toll booth fee at entry and exit of Town.

The Committee agreed that additional details will need to be confirmed with respect to a "Chase the Ace" or alternative. The Lobsterfest and Oktoberfest events will be discussed at a subsequent meeting.

C.3 Christmas Dinner Update and Sponsorship - Councillor Rob Sampson (verbal)

Councillor Sampson reported that 500 meals are being prepared as part of a Christmas dinner offering, 250 of which are being distributed through St. George's church/community cares program and 250 of which will be available for anyone to pick up at the community centre on December 19, 2020. It was noted there is no cost associated with the meals, but individuals are welcome to donate to the cause, or contribute what they are able to when they pick up their meals. It was noted that \$3,000 has been raised through the community for the initiative and there may be additional donations through community organizations like Rotary, and private community members. Councillor Sampson noted that if the initiative is not able to raise all the funds to cover the event, Grants and Donations Committee may be asked to donate. Director of Finance and IT Services Ruth Prince confirmed there is over \$7,000 available should Grants and Donations need to consider making a contribution.

Councillor Bordignon noted the Town is also working with the business community, ministerial community and other stakeholders to produce professional quality holiday videos that feature faith ministry, local entertainers, greetings, and shots of the local landscape.

Committee member Marc Anthony Venere expressed an interest in being able to donate to the 250 community meals and the Committee discussed the best manner to do so. Committee member Linda Wykes will provide program information to the Grants and Donations Committee members. Director of Finance and IT Services Ruth Prince confirmed that if donations are being made through the Town, the cheque needs to be made out to Town of The Blue Mountains. Councillor Rob Sampson confirmed that any additional funds raised will be donated to St. George's food program for the 2021 year.
