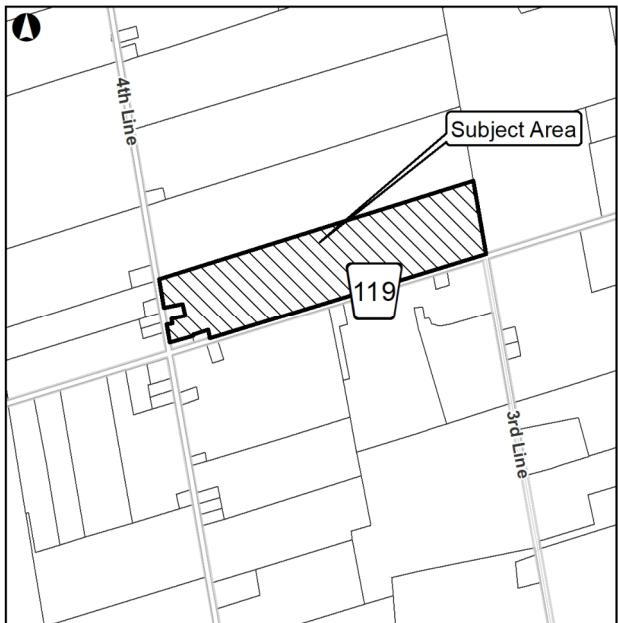
What is being proposed?

The purpose of the application is to consider a request for minor variance to Sections 4.1.2 (f) and (c) of Zoning By-law 2018-65. The Owner wishes to construct a new main dwelling, requiring the change of use of an existing dwelling to an accessory apartment. No modifications to the existing dwelling are proposed.

The effect of this application is to permit:

1. The construction of a new main dwelling located 65 metres from an accessory apartment, whereas a maximum of 50 metres is permitted; and
2. The change of use of the existing dwelling to an accessory apartment with a height of 6.0 metres, whereas a maximum of 4.5 metres is permitted.

The legal description of the subject lands is Concession 4 South Part Lot 16.



What happens at the Public Hearing?

The public hearing is your chance to make your views about the proposal known. Information from the public will help the Committee in their decision-making process, so make sure to have your say!

Written Comments: You are encouraged to provide your comments or questions in writing using email or regular letter mail to the Secretary Treasurer. Written comments received before 1:00pm the day before the meeting will be read by the Secretary Treasurer at the Public Meeting for the benefit of everyone in attendance and will be included in the record of the Public Meeting. Verbal Comments: This Public Meeting is a hybrid meeting, allowing the public to attend the meeting in person or virtually. Those that wish to make verbal comments virtually are required to pre-register with the Secretary Treasurer, no later than five days in advance of the Public Meeting, by September 15, 2023

Anyone wishing to provide their verbal comments in person at the Public Meeting, can attend at Town Hall Council Chambers and are required to follow the Public Health Guidelines of the Town, as recommended by the Grey Bruce Health Unit.

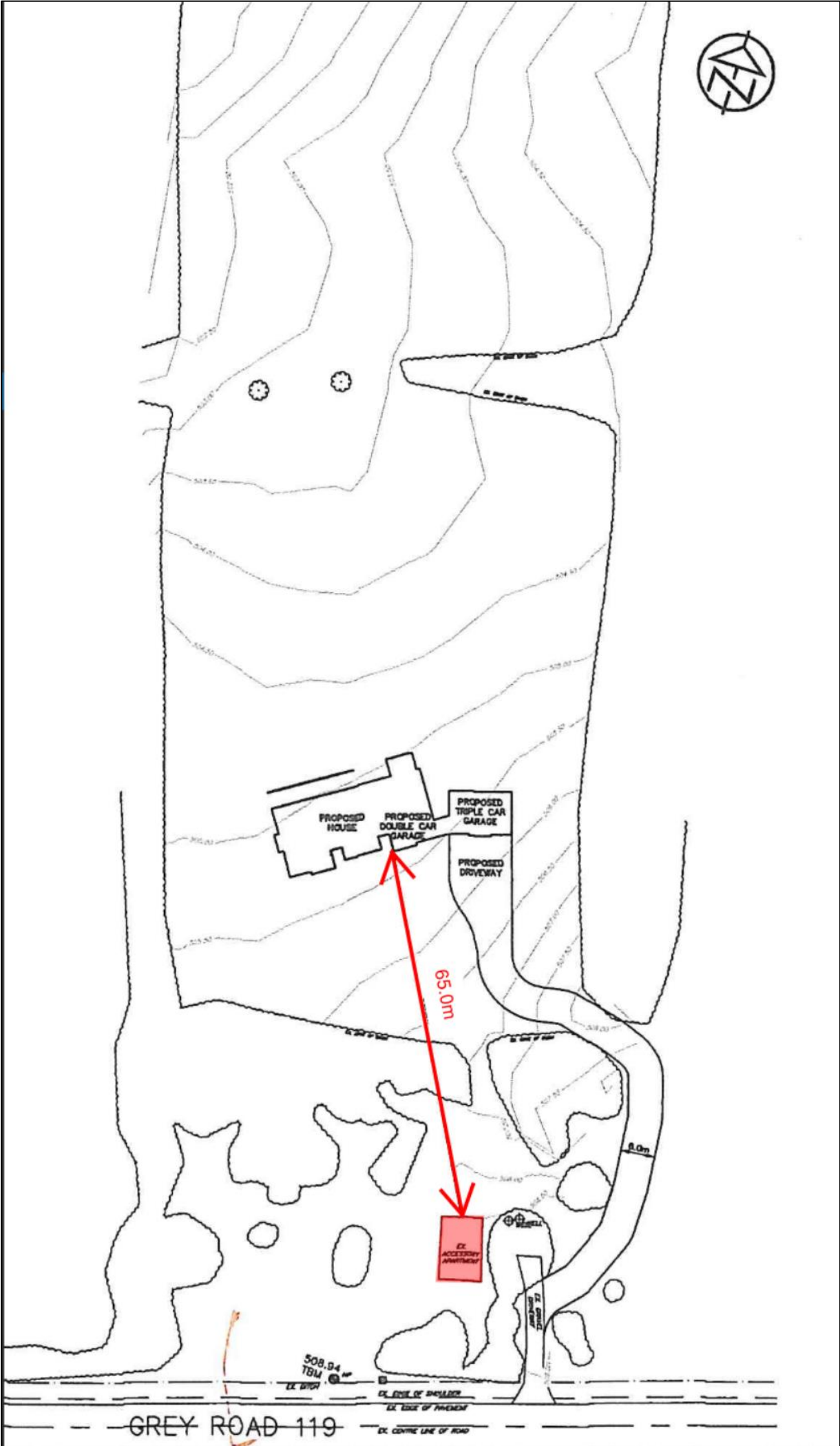
