


What is being proposed?

The proposal is to rezone a portion of the property know as 207484 Highway 26 (site of the former Black Angus Meats), to allow a Contractor's Yard to be established.

Currently, the subject property is zoned both Rural (RU) and Rural Employment Exception (M2-5) zone. The area where the buildings and structures are located is the area that is zoned M2-5. The Exception 5 currently permits only an abattoir associated buildings and structures, and accessory uses. This application seeks to change the Exception 5 to allow the Contractor's Yard use and delete the abattoir use; no new structures are proposed at this time.

The legal description of the property is Part of Lot 36, Concession 11 (formerly the Township of Collingwood).

Your rights to appeal a decision: If a person or public body would otherwise have an ability to appeal the decision of Council of The Blue Mountains to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to Council before the by-law is passed, the person or public body is not entitled to appeal the decision. If a person or public body does not make oral submissions at a public meeting, or make written submissions to Council of The Blue Mountains before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
