A. Recommendations

THAT Council receive Staff Report FAF.24.038, entitled "Georgian Hills Vineyard Follow-Up Report 2024 and 2025 Noise By-law Relief Requests";

AND THAT, further to consideration of Staff Report FAF.24.032 entitled "Georgian Hills Vineyard 2024 and 2025 Noise By-law Relief Requests" considered at the February 26, 2024 Committee of the Whole meeting, Council approves the requests for relief from the provisions of the Noise By-law for Georgian Hills Vineyard for the 2024 and 2025 calendar years, as listed below, with the following conditions:

- Georgian Hills Vineyard shall designate a responsible person that can be contacted real
 time during events and with municipal enforcement response contact information being
 provided by the Town to the residents within one hundred and twenty (120) meter
 radius of the Georgian Hills Vineyard property;
- 2. Georgian Hills Vineyard will provide decibel data for six events in 2024 and six events in 2025 to be determined and requested by Town staff post events, and additionally where a complaint has been received by the Town; and
- 3. All 2025 events at Georgian Hills Vineyard will be by a DJ that has been as authorized by Georgian Hills Vineyard.

B. Overview

This report provides further information to Staff Report <u>"FAF.24.032 Georgian Hills Vineyard 2024 and 2025 Noise By-law Relief Requests"</u> considered at the February 26, 2024 Committee of the Whole meeting.

C. Background

This report is provided further to the February 26, 2024 Committee of the Whole meeting regarding Staff Report FAF.24.032, where the Committee provided the following recommendation:

B.9.1 Georgian Hills Vineyard 2024 and 2025 Noise By- law Relief Requests, FAF.24.032

THAT Council receive Staff Report FAF.24.032, entitled "Georgian Hills Vineyard 2024 and 2025 Noise By- law Relief Requests";

AND THAT Council authorizes the requests for relief from the provisions of the Noise Bylaw for the 2024 and 2025 events listed in staff report FAF.24.032, on the condition that:

- 1. Georgian Hills Vineyard designates a responsible person with real-time contact information provided to neighbours;
- 2. Georgian Hills Vineyard will provide decibel data for six events, as identified by staff, and additionally where a complaint has been received
- 3. 2025 events will be by a DJ as authorized by Georgian Hills Vineyard

AND THAT Council direct staff to provide a report to Council, prior to further exemption requests, for Council consideration.

D. Analysis

Georgian Hills has submitted similar Noise By-law exemption requests in previous years and Council has granted those requests with some modifications.

Staff has included in the recommendation of this report within Condition 1 that the Town shall provide residents within the one hundred and twenty (120) meter radius of the Georgian Hills property. This radius will include the residents that received the original notice of this Relief to

the Noise By law request. This ensures that complaints are received through the Municipal By law call service, and that calls are logged, responded to and tracked. This process is also consistent with the Municipal Licensing Responsible Person protocol.

The majority of the listed events that are included in the recommendation have identified maximum capacities of between sixty (60) and one hundred and fifty (150) people. There are two charity events that are scheduled for Sundays that have capacities of two hundred and fifty (250) in 2024 and three hundred (300) in 2025. These two larger events have a timing of 11a.m. to 6p.m. and do not continue into the evening hours.

It is important to note and clarify that Town staff does retain the ability to revoke the relief of the Noise By law that Council may provide approval where it has been determined by Town staff that the conditions that have been identified have not been fulfilled and where the activities of events have become a nuisance based on the findings of staff. Staff also acknowledge that this determination will require the provision of evidence of the conditions not being fulfilled and or the nuisance has been determined. In addition, it is anticipated that some of this evidence will also be based on the subjectivity of the responding Municipal By law Enforcement Officers, Town staff or the Ontario Provincial Police. Consideration of such revocation will require consultation with the Owners of Georgian Hills Vineyard. Staff suggest that based on the conditions contained in this report it is fully expected and anticipated that implementation of the precautionary measures will be in place to avoid concerns in the future, however staff felt it necessary to include this point for clarity and transparency for all parties.
