- Can Council ensure that these updates are communicated transparently and regularly to the public?






January 17, 2022: CAO releases staff report to announce Campus of Care.

February 7, 2022, Virtual Public Meeting on Declaring a Portion of 125 Peel Street as Surplus: 0 members of the public attend the meeting and 0 written comments are received by the Town Clerk. March 7, 2022, Public Feedback Requested Regarding the Community Campus of Care: Window for written comments opens on Town's website on March 7 and closes March 10 @ 12PM (12 written comments are received).

November 22, 2022: Public notice posted on the draft of the CIHA (Community Infrastructure and Housing Accelerator): All questions and comments are to be submitted in writing (no information available on written comments received).

- 786 parking spaces




Call To Action: Shaping Our Future Together
