### Application for a Minor Variance to Zoning By-law 83-40

**Property Location:** Parts of Lots 6, 10, 14 and 15 and Part of Village Crescent

**Public Meeting:** November 20, 2024 at 1:00pm

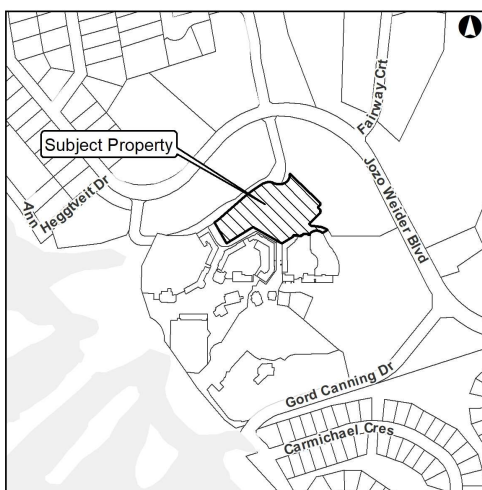

### What is being proposed?

The Owner is seeking a minor variance to permit the construction of five (5) storey Village Commercial Resort Unit complex with a total of 196 Village Commercial Resort Units and 1,748 square metres of commercial space across ten (10) commercial units to be located on the first-floor level. One (1) level of underground parking that will be accessed via the northeast corner of the building.

The purpose of this application is to consider a request for a minor variance from Section 5.8 (b)(i), Section 15.2 (c), (e) and Section 15.9 (e) of the Zoning By-law to permit:

1. A development on a lot which fronts on a private road;
2. An increase of maximum lot coverage from 30 % to 32 %;
3. A reduction in the required minimum front yard setback from 15 metres to 7.5 metres;
4. A reduction in required minimum surface parking from 30% to 0% surface parking space.



### What happens at the Public Hearing?

The public hearing is your chance to make your views about the proposal known. Information from the public will help the Committee in their decision-making process, so make sure to have your say!

**Written Comments:** You are encouraged to provide your comments or questions in writing using email or regular letter mail. Written comments received before 9:00am on November 18, 2024 will be read aloud at the Public Meeting. Comments received after this deadline will not be read aloud but all comments will be circulated to Staff and the Committee. To ensure enough time for circulation and review of your comments, please submit them prior to the day of the meeting. **Verbal Comments:** This Public Meeting is a hybrid meeting, allowing the public to attend the meeting in person or virtually. Those that wish to make verbal comments virtually are required to pre-register with the Secretary Treasurer, no later than five days in advance of the Public Meeting, by November 15, 2024.

Anyone wishing to provide their verbal comments in person at the Public Meeting, can attend at Town Hall Council Chambers and are required to follow the Public Health Guidelines of the Town, as recommended by the Grey Bruce Health Unit.

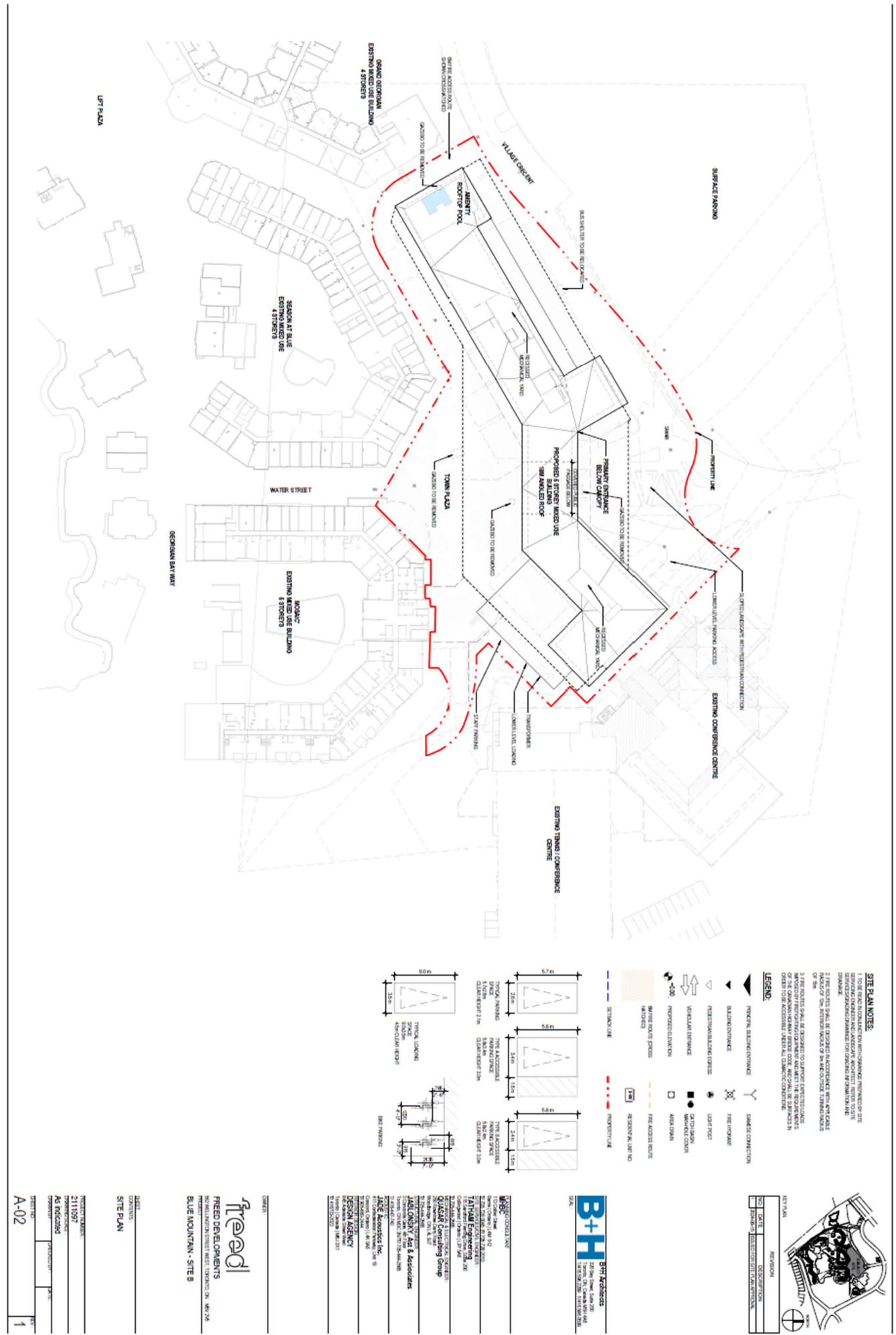
