A. Recommendations

THAT Council receive Staff Report FAF.24.151, entitled "Lobbyist Registry By-law Training";

AND THAT Council receives the training regarding Council's requirements as defined in the Lobbyist Registry By-law 2024-72, from the Town's Lobbyist Registrar, Jeff Abrams of Principles Integrity

B. Overview

At the November 12, 2024 Council Meeting, Council enacted the Lobbyist Registry By-law 2024-72. This staff report provides background information regarding the enactment of the Lobbyist Registry By-law and introduces the Lobbyist Registrar, Principles Integrity.

C. Background

Council has moved through the process for the establishment and enactment of a Lobbyist Registry By-law. This process included a Public Meeting, followup staff reports, and entering into an agreement with the Town's Integrity Commissioner, Principles Integrity for the provision of Lobbyist Registrar services. Staff Report <u>FAF.24.097 Establishment of a Lobbyist Registry By-law</u> is provided for background information.

D. Analysis

Lobbyists are now required to register their lobbying activities through the Town's website. Lobbyists are encouraged to start the registration process now. When registering, Lobbyists are required to acknowledge they have read the Lobbyist Code of Conduct as attached to the Lobbyist By-law 2024-72, and to acknowledge that in the previous 12 month period that they have not held a "Public Officer Holder" position with the Town, as defined in the Lobbyist Bylaw 2024-72.

It is noted that "Section 9: Enforcement and Penalties" of the By-law does not come into effect until May 12, 2025.

For reference, attached to this staff report is the Lobbyist Registry Bylaw 2024-72, Frequently Asked Questions document, and the "Am I A Lobbyist" flowchart.
